MINUTES OF THE DDC MEETING HELD ON 05.01.2021 AT 11.00 A.M. IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smti. Banashree Nath, ACS, DDC, Dhubri. She welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

1. TOWN & COUNTRY PLANNING:

The Deputy Director, T&CP, Dhubri briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that under PMAY-HFU a total of 5296 nos. of houses have been completed and Geo-Tagged. Another, 2412nos. of Houses has been completed but yet to be Geo-Tagged.

On query about status of PMAY -(U) of Golokganj M.B, the Deputy Director, T&CP, Dhubri informed that 1217 nos. of beneficiaries have been finalised under Phase -I for the Golokganj MB area and the Geo tagging of the same will start soon. At present appointment of MIS and field level workers are in progress.

The Chairperson requested him to visit the Golkganj Town personally and get started the Geo-Tagging works immediately.

The Deputy Director, T&CP, Dhubri informed that the Govt. has directed to submit new proposals under PMAY(U) by 6th January'2021. He further informed that the Govt. has posted GIS expert in the district. Earlier the GIS was done through private parties.

2. Forest:

The DFO, Dhubri reported that the Task Force has seized Timber =7.716cum, Earth=14131.14 cum, JCB =1No., Tractor =04 nos, Dumper = 2Nos, Bench Saw Mill = 1 Set. And Bolero Van = 1 No. in the month of December*2020. The Revenue collected during December/2020 is Rs. 1,00,81,853/- and cumulative Revenue collected up-to month of December/2020 is Rs. 2,30,23,975/-

The Chairperson informed that as per report received, extraction of sand is taking place at the sites of newly silted areas resulted from pre-siltation measures especially in Dharmasala area. She requested DFO, Dhubri to look into the matter personally and check extraction of sand from such areas.

3. D.I & C.C :

The G.M, DI&CC, Gauripur informed that altogether 601nos, of applications were sponsored under PMEGP for the financial year 2020-21 and so far they have received sanction for 60 nos, beneficiaries.

- DIC = 45 nos.
- ii) KVIC = NIL
- iii) KVIB = 15 nos.

In case of SVAYEM they have received sanction for 1423 nos. of beneficiaries against 4468 and fund disbursed to 400 nos. of beneficiaries till date. He informed that the due to non-deposit of beneficiary's share of Rs.15,000/-, there is less progress in the disbursement of loans against sanction numbers.

4. AGRICULTURE :-

The DAO, Dhubri briefed the house of different schemes being implementation in the District.

- KCC: The DAO, Dhubri informed that till date 504 nos. of KCC applications have been sponsored to the Banks for sanction. The target for the District is 12000 nos.
- (ii) The DAO, Dhubri informed that the under PMFBY,2020-21, Insurance has been done covering 35507 nos. of farmers with an area insured for 15971.299 Hectare for different crops like Black Gram, Jute and Sali Paddy.
- (iii) The DAO, Dhubri informed that the Seeds and Input distribution in the District has been completed including the distribution of Strawberry Plant and Plastic mulching which was received recently.
- (iv) Under CMSGUY Phase I & II altogether 687 nos. of Tractors have been distributed .to groups out of target 874 nos.

5. PHE:-

The E.E, PHE, Dhubri informed that the Geo-Tagging of entire IHHL numbering 147251 for the years 2019-20 &2020-21 under Swachh Bharat Mission (G) has been completed.

On query from the Chair, the E.E, PHE, Dhubri informed that under LOB (Phase-I), 5799 nos. of IHHL out of targeted 5799 nos. have been completed. Similarly, a total of 17387 nos. of IHHL out of targeted 24454 nos. have been constructed till date under the scheme NOLB (LOB-Phase-II).

The E.E, PHE, Dhubri further informed that under convergence scheme with P&RD Department Running Water Supply scheme will be taken up in the schools for which 75% fund will be borne by the P&RD Department. The work will be taken up from the P&RD Department.

It was informed that the Jal-Jeevan Mission in the District is going on smoothly.

6. AUS&SB :-

The representative of E.E, AUS&SB, Dhubri informed that the Dhubri Water Supply scheme has been commissioned and is now under operation and maintenance. At present 724 household are enjoying the benefit of the scheme. Similarly, the Gauripur Water Supply scheme has also been commissioned and at present 178 nos. house-holds are enjoying the benefit of the scheme. The commissioning of Bilasipara Water Supply scheme will be done on 10th of this month.

It was further informed that the construction of Overhead Tank at Paulpara is under progress.

7. COOPERATION:-

The representative of DRCS, Dhubri informed that as resolved in the last DDC meeting held on 05.12.2020, necessary auditing of expenditure and verification of accounts in respect of 04 groups out 12 group of registered Societies have been verified by his officials.

8. LEGAL METROLOGY :-

The Asstt. Controller, Legal Metrology informed that as instructed he has checked the trucks carrying goods at International Trade Centre, Lakhimari and found overloading in some cases.

9. PWD Roads:-

The E.E, PWD Dhubri Civil Sub-Division, Territorial Road Division informed that the work in respect of scheme viz. Construction of Approaches road RCC Br. No. 2/1 and 3/1 on old NH at 5th Km to IBB Road near Sonahat BOP has been so far completed about 92% and same will be completed within February/2021.

Regarding SOPD schemes, the E.E., PWD Dhubri Civil Sub-Division, Territorial Road Division informed that the progress of works taken up under the scheme are in progress and likely to be completed within stipulated time. Further, he informed that another 43 nos. of schemes have been sanctioned under SOPD for the year 2020-21.

The Senior Planning Officer, Dhubri informed that a Paper Cutting regarding bad quality of works being done on the const. of road from N.H.31 Golokganj Chariali to Tokrerchara village via Radharani house to Mukund Ch. Rai house has been received and accordingly he requested the E.E, PWD Dhubri Civil Sub-Division, Territorial Road Division to look into the matter and take corrective action. The E.E, PWD Dhubri Civil Sub-Division, Territorial Road Division informed that already action in this regard for resurfacing has been taken up.

The Senior Planning Officer, Dhubri requested the E.E., PWD Dhubri Civil Sub-Division, Territorial Road Division to give a clarification in this regard in the paper with a copy to this end.

10. Health :-

The Joint Director of Health Services, Dhubri informed that the mock drill on COVID vaccine training will be done shortly. The list of Health Workers and Private Doctors have been uploaded as per direction of the Govt.

Regarding distribution of insecticide mosquito nets, it has been informed that they have distributed the mosquito nets in Raniganj and Dharmasala Dev. Blocks. The same will be done for other blocks shortly.

On query, it was informed by the Joint Director of Health Services, Dhubri that the 90% to 95% of immunisation target will be covered in the District by March 2021.

Regarding registration and Insurance of Boat Ambulance purchased under .CSR, it was stated that the Authority of Inland Water Transport has informed that engagement of permanent staff for the boats is a prerequisite for registration and insurance of Boat Ambulance. It was resolved that the Joint Director of Health Services, Dhubri to bring this to the notice of District Administration for further necessary action.

11. Fishery :-

The DFDO, Dhubri informed that under APART 2020-21, fund against the scheme "Carp Poly Culture Demo has been received by the P.D, ATMA, Dhubri and will cover 32 Hectares involving 5 nos. Farmers Producer Groups (FPG) under the scheme. In this regard, the concerned FPG has already procured inputs.

Further, 104 nos. of beneficiaries have been approved against various activities under the scheme Pradhan Mantri Matsya Sampada Yojana (PMMSY). Similarly, beneficiary list has been approved and work order issued against concerned beneficiary under the scheme RKVY-RAFTAAR (Remunerative Approaches for Agriculture and allied sectors Rejuvenation).

12. Sericulture :-

The Assistant Director, Sericulture, Dhubri informed that the land at Tushpara measuring 20 Bighas has been taken over for cultivation of Som and Eri in convergence with the DRDA, Dhubri.

13. Skill Development :-

The DPM, Assam Skill Development Mission, Dhubri District informed that a total of 1261 nos. of candidates have been provided with Certificates under the scheme State Funded Placement Linked Skill Development Training Program of Assam Skill Development Mission covering different sectors like Apparel, Media & Entertainment, Agriculture, Retail, Plumbing, CSDCI, MEPSC, Electronics etc.

Similarly 490 candidates have completed training and obtained certificates under different trades under Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2.0 Central Sponsored Central Management (CSCM).

The SPO, Dhubri requested him to submit write up stating the success story of the schemes in regard skill development in the District.

INTER-DEPARTMENTAL:-

- The DAO, Dhubri informed that under the scheme Food Security Mission, 359 farmers will be provided with 2 H.P Single Phase Motor and accordingly he requested APDCL officials to render necessary help to the farmers as and when they apply for power connection.
- The DFE (SMIBCB), ASRLM, Dhubri requested LDM, Dhubri to provide necessary help in the opening of Bank Accounts of newly formed 849 SHG.
- The LDM, Dhubri informed that the linkage percentage in Dhubri District has risen upwards to 38% from the last year percentage of 07%, which is a laudable achievement on the part of banking sector in the District.
- The LDM, Dhubri informed that an ATM is to be installed in the area of Chapar T.E and in this connection they have been served with a bill of Rs. 4.00 lakhs for electrification purpose by the APDCL. He requested the APDCL authority for considering in the reduction of electric connection bill for installation of ATM in the Chapar T.E. in the greater interest of Tea Garden workers.

The meeting then ended with vote of thanks from the Chair.
