# MINUTES OF THE DDC MEETING HELD ON 06.01.2020 AT 11.00 AM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smti. Banashree Nath, ACS, DDC, Dhubri. She welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

## 1. TOWN & COUNTRY PLANNING:

The Deputy Director, T& CP, Dhubri briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that under PMAY-HFU, out of total approved beneficiaries of 17933 (including 3<sup>rd</sup> & 4<sup>th</sup> DPR), a total of 1882 nos. of houses have reached the completed state. Another 711 nos. of houses are at roof level and 4124 nos. of houses are at lintel level.

The Chairperson requested the Deputy Director, T& CP, Dhubri to fix target date for completion of construction of houses taken up during 2017-18 and 2018-19 and direct ULBs to monitor the same from their end.

Further, in case of construction of Sapatgram Town Committee Building under 10% Pool Fund, it has been informed that the Civil Works of the Building has been completed. However, the Water Supply & Electrical works are remained to be done. The work is likely to be completed by March'2020 in whole aspects.

The DDC, Dhubri informed that a team from T&CP Department, Assam will visit the District in this month to oversee the Dhubri Master Plan and requested the Deputy Director, T& CP, Dhubri to render necessary support to the team.

#### 2. FOREST :-

The DFO, Dhubri reported that the Task Force has seized Sal Timber =0.897 cum, Earth=32.854cum, Vehicle=10 Nos, Sand = 5.524cum, Stone = 30.031 cum, , Boat = 2 Nos, in the month of December 2019.

The Chairperson informed that illegal sand gravelling collection going on in the district and requested the representative of DFO, Dhubri to take steps for sudden raids and seize of the tractors used for the purpose as well as legal action against the culprits. Action Taken report in this regard be submitted within 15 days.

It was further resolved that the DFO, Dhubri will submit a report in respect of Brick Kiln owners activities to the District Authority for appraisal.

## 3. AH & VETERINARY:

The Dist. A.H &Veterinary Officer, Dhubri informed that the target for artificial insemination for the district has been fixed at 20,000 nos. and cumulative achievement of Calf Born till December 2019 is 4858 nos. Under Prevention of Livestock Diseases, the target is 3,00,000 doses and they have provided 83232 doses till last month. In case of Deworming of new born Calf, it was reported that so far 10517 nos. of Calf were taken care under the scheme.

On query, the Dist. A.H &Veterinary Officer, Dhubri informed that the District Level Meeting on insemination was held on 30.12.2019. Further, 15 nos. of trainee have taken training under the scheme Gopal Mitra.

Regarding status of construction of Veterinary Office Building, it was reported that so far about 95% works have been completed and the same is likely to be completed by this month.

#### 4. APDCL:

It was informed by the SDE, Dhubri Electrical Sub-Division that they have received 196461 nos. of LED bulbs under MMADY scheme and has so far distributed 93556 (in packet of 4 nos.). In Dhubri town they have distributed bulbs to 13950 nos. families. Beside they have electrified a total of 517661 nos. of Households including additional 2711 HH.

The SDE, Dhubri Electrical Sub-Division further informed that at present the IPDS 2018-19 is under progress in the town of Dhubri, Gauripur, Bilasipara, Sapatgram and Chapar and so far 83% completed. It was assured that the work is likely to be completed in the month itself.

The SDE, Dhubri Electrical Sub-Division informed that he has taken up the mater regarding providing electricity connection to Moynabandha PWSS with his counter-part AGM, APDCL, Goalpara. As per information the connection to the PWSS couldn't be provided because of pending payment of enhanced GST bill, which is yet to be deposited by the PHE Department. The Chairperson requested SDE, Dhubri Electrical Sub-Division to render necessary help for early connection.

As resolved in the last DDC meeting the joint visit by the team of AGM, APDCL, Gauripur and N.H.Way Officials for on the spot study of shifting of Transformer installed near Beparipatty Masjid for

installation of Signage in connection to Rupshi Airport couldn't be done. The Chairperson again directed for on the spot visit by the AGM, APDCL, Gauripur and N.H.Way Officials by today itself and sort out the problem.

It was further informed by the SDE, Dhubri Electrical Sub-Division that the land for construction of 5 nos. of Control Units sanctioned for Dhubri District including two for Bilasipara Sub-Division has yet not been allotted. The Chairperson requested SDE, Dhubri Electrical Sub-Division to take up with concerned Circle Officers for allotment of land.

#### 5. PWD (NH):-

The DDC, Dhubri requested the A.E.E. PWD, Bilasipara NH Sub-Divn. to go for alignment of road as the vehicles bumps while driving, though the roads was constructed recently.

## 6. Sales Tax Deptt :-

The Supdt. of Taxes, Dhubri informed that the revenue collected in the month of December'2019 is Rs. 76293890/- and the cumulative total stands at Rs.609697006/-.

#### 7. Irrigation Deptt:-

The EE, Dhubri Division Irrigation, Gauripur informed that renovation work of Asharikandi LIS Ph-I under SOPD-SCSP with an estimated amount of Rs. 52.20 lakh is under progress and so far 75% works have been completed. On query, the EE, Dhubri Division Irrigation, Gauripur informed that constn. of canal is in progress. However, NOC from Railway authority is needed to complete the construction works. The Chairperson suggested him to take up the matter with the Railways immediately.

Further, on query, the EE, Dhubri Division Irrigation, Gauripur informed that three nos. of schemes have been taken up under NABARD XXIV and the progress of the schemes are 59% only. The schemes are

- Kurirpar Solar Powered DTWS (1 Point)
- ii) Andujhar DTWS (1 Point)
- iii) Kurshakati DTWS (1 Point)

As the progress of schemes are 59% only and the contractors are not interested in completion of the works, the Chairperson requested the EE, Dhubri Division Irrigation, Gauripur to issue final notice to the contractors for completion of the works within one month time with copy to their Higher Authority.

Regarding implementation of Solar/Electrical TWS under Pradhan Mantri Krishi Sichayee Yojana-Har Khet ko Pani (100 Nos.), it was resolved that the EE, Dhubri Division Irrigation, Gauripur will provide the list of Pin-Points of solar to the AGM, APDCL, Gauripur and who in turn will submit the cost of implementation and to take necessary action.

#### 8. Health Dept :-

The Joint Director of Health Services, Dhubri informed that the first phase of Mission Indradhanush has been completed in the month of December'2019 and the overall immunisation achieved against Pregnant women and children below 7 years is 98%. The second phase of immunisation under the scheme has been started from 2<sup>nd</sup> of January'2020.

On query from the Chair, the Joint Director of Health Services, Dhubri informed that the district is affected by Diphtheria in epidemic form and the people above 6 years have been badly affected. They have taken all preventive measures to treat such patients.

Regarding the scheme distribution of Antara Contraceptives it has been reported that there is short supply of the same. However, the achievement is above the target. In case supply of Antara is regularised, the achievement can be increased.

The Chairperson requested the Joint Director of Health Services, Dhubri to submit reports on Ayushman and Atal Amrit Yojana to District Administration every month for appraisal. It was further decided that the Joint Director of Health Services, Dhubri will visit the Golokganj Sub-Centre and to submit report on the progress of construction works going on under MSDP and MPLAD.

## 9. PHE:-

The E.E, PHE, Dhubri informed that the Geo-Tagging of 145514 nos. of IHHL out of 147477 (98.68%) for 2019-20 under Swachh Bharat Mission (G) has been achieved. He informed that the cent-percent Geo-Tagging cannot be done as because the IHHL constructed during 2013-14 couldn't be tagged.

The E.E., PHE, Dhubri informed that PWSS at Lakhimari Pt-III could not be made functional because of non-availability of H.T Line. The Chairperson requested AGM, APDCL, Gauripur to take suitable steps for installation of H.T. Line at Lakhimari Pt-III village at the earliest in consultation with the Forest Department.

It was further informed by the E.E, PHE, Dhubri that the existing Transformer at Tiamari PWSS installed by the APDCL has been removed for repairing but the same is not reinstalled till date for which supply of drinking water has been affected. The Chairperson requested AGM, APDCL for reinstallation of the same immediately.

## 10. Agriculture :-

The DAO, Dhubri informed that the distribution of Power Tiller under the scheme BGREI for the year 2018-19 and 2019-20 is under progress. He informed that the demand for the Power Tiller has been declined because of availability of Tractors under CMSGUY.

Regarding, distribution of Tractors under CMSGUY, it was informed that the left out 38 nos. of tractors under Ph-I will be distributed in the Ph-II.

It was further informed that only 212 nos. of KCC have been sponsored to the banks. The DDC, Dhubri requested him to submit action taken report for appraisal.

The DAO, Dhubri informed that 2 nos. of Agril Clusters have been done. Beside, 100 MT Godown will be constructed in the Dist. Agriculture Campus. The DDC, Dhubri requested the DAO, Dhubri to share the Pin\_Points of Agril. Clusters with the Irrigation Department.

## 11. DI&CC:

On query from the Chair, the G.M, DI&CC, Gauripur informed that the proposals under PMEGP has been forwarded to the banks and so far only 17 nos.( DIC- 16 & KVIC- 1) of sanction has been accorded by the banks. The Chairperson requested G.M, DI&CC, Gauripur to provide the copy of the sponsored list along with bank's name for her knowledge. It was also decided that the LDM will direct Cooperation Bank to sanction PMEGP.

## 12. PWD (Building) :-

The E.E., PWD (Bldg), Dhubri informed that the work order for execution of recently allotted MSDP schemes have been given. The DDC, Dhubri suggested him to complete the schemes by February 2020 and submit bills for release of funds.

It was further informed that under Signature Project, the work viz."Construction of ISBT at Bilaspara is under progress. Beside, tender for const. of Golokganj Stadium has been called for.

On query the E.E, PWD (Bldg), Dhubri reported that the drawing for const. works of Madhupur Satra is yet to be received from the Chief Engineer Office. The DDC, Dhubri requested him to take up with the Chief Engineer's Office and start the const. works at the earliest.

Regarding const. of Cancer Hospital, the E.E. PWD (Bldg), Dhubri informed that the land for the same is yet to be allotted. However, he has received Drawing in this regard. The Chairperson requested him to discuss the matter with the Deputy Commissioner, Dhubri for allotment of land.

## 13. Water Resources :-

The A.E.E, Dhubri W.R. Division, Dhubri informed that the work of the new scheme sanctioned under NABARD-RIDF for protection of one & halh Km. of reach on the Right bank of down- stream of River Gangadhar has been started and so far 45% physical progress have been achieved. He further informed that they have submitted proposal and estimate for Protection works at Binnachara under SOPD.

The DDC, Dhubri requested him to pursue the matter with Govt. for sanction of the same.

It was decided that for taking up any protection works under MPLADS, MLALADS, MGNREGA, the executing agencies must obtain permission and Feasibility Report from the Water Resources Deptt. alongwith Plan Estimate, NDC etc. for sanction of the scheme.

## 14. AUWS&SB:-

The Chairperson directed the AGM, APDCL, Gauripur to take steps for removal of electric wire line running over the Water Reservoir at Paulpara within a week as the matter has already been delayed.

## 15. Social Welfare :-

POSHAN Abhiyan: The DSWO, Dhubri informed that they have received the necessary Weighing Machines and other instruments including mobiles under the scheme POSHAN Abhiyan. So far configuration of 3000 nos. of mobiles provided to them has been done. District and Project Level functionaries has yet to be engaged.

SUPPLEMENTARY NUTRITION PROGRAM UNDER ICDS: The DSWO, Dhubri informed that the fund for the months of January and Fenruary 2020 have been released to the ICDS.

<u>DEEN DAYAL DIVYANGJAN PUNAR SANSTHAPON ACHONI</u>:- It was reported that the selected list of 66 Nos. of beneficiaries has been forwarded to the Directorate to directly transferred the benefit to the account of the beneficiary concerned.

The DSWO, Dhubri informed that she has received notice for shifting of AWCs functioning in the school campuses of High Schools and L.P Schools and requested Chairperson for necessary guidance in this regard. The DDC, Dhubri suggested her to take up the matter with the DMC, SSA, Dhubri in this regard.

Further, on request from the DSWO, Dhubri, the Chairperson requested PD, DRDA, Dhubri and SPO, Dhubri to provide the list of AWCs to the DSWO, Dhubri which are taken up for construction under MGNREGA and MSDP respectively. It was also resolved that the completed AWCs under MGNREGA and MSDP be handed over to the CDPOs and not to Anganwadi workers henceforth.

# 16. Handloom & Textiles :-

The Asstt. Director, H&T, Dhubri informed that 40% achievement has been achieved against the scheme viz. "Economic Upliftment of Weavers through Handloom Weaving under SOPD-G for Plan General at Bahalpur. The rest couldn't be achieved due to non-receipt of Handloom equipment from the Directorate. The Chairperson requested him to take up the matter with their H.O and to achieve the target. It was further resolved that the Asstt. Director, H&T, Dhubri will take up with the Directorate of H&T, Assam for filling up of vacant post at Dhubri Office.

# 19. Agriculture Marketing :-

On query, the Secretary Dhubri Dist. Regulated Market Committee informed that there is a proposal of procurement of 25000 MT Paddy by them.

The Chairperson directed the Secretary Dhubri Dist. Regulated Market Committee to take immediate steps for not allowing the parking of trucks round the clock at the Market Complex at Dhubri as same has become a nuisance to the area.

#### 20. NULM :-

The CO, NULM, Dhubri informed that the target for formation of SHG under the scheme Social Mobilisation & Institutional Development has not been achieved in respect of Bilasipara, Gauripur and Chapar. He assured that the same will be achieved within the month of Feb'2020.

# 21. Employment Exchange:-

The Chairperson, Dhubri requested the A/D, Employment Exchange, Dhubri to submit a report on vacant position for appraisal.

#### 22. Soil Conservation :-

The D.O, Soil Conservation, Dhubri informed that schemes under IWMP (8nos.), SOPD-G (3 nos.) and RIDF-XXI (1no.) are in progress. The DDC, Dhubri requested him to fix dates for monitoring of the same in consultation with her.

## 23.Cooperation :-

The DDC, Dhubri requested the DRCS, Dhubri to verify the Dairy Cooperative Societies in consultation with the Dist. A.H & Vety. Officer, Dhubri and submit report.

It was also decided that the Dairy Cooperatives can be taken up under SVAYEM and directed G.M, D.I & C.C, Gauripur to discuss the matter with the Dist. A.H & Vety. Officer, Dhubri and submit proposals accordingly.

The G.M, D.I & C.C, Gauripur informed that under Potter Skill Development 100 families from Asharikandi has been covered and for this Rs. 1 Crore has been sanctioned. The DDC, Dhubri suggested for joint verification by G.M, D.I & C.C, Gauripur and DRCS, Dhubri on the matter.

#### 24. Fishery :-

The DDC, Dhubri requested the DFDO, Dhubri to submit a report on requirement of fish in the District for appraisal. It was also resolved that the DFDO, Dhubri will fix target under KKC from his end if the target from the Govt. is not yet received and submit to Banks.

The DFDO, Dhubri informed that the allotment of land for construction of Fishery Office Building is not yet done. The DDC, requested him to write to the concerned Circle Officer with copy to Deputy Commissioner, Dhubri for allotment of land.

#### 25.BADP & Other Schemes:-

The House reviewed the progress of different schemes implemented under BADP, MPLAD, MLAADS and requested implementing agencies to expedite the completion of works and submit UCs.

### MISCELLANEOUS :-

- The DDC, Dhubri informed that Torch Relay function for "Khelo India" will be held in Dhubri Jhagrarpar Stadium on 7<sup>th</sup> January 2020 at 8.00 A.M. and requested all to attend the function.
- 2. The Chairperson informed that the GOI in the Department of Commerce has informed through Office Memorandum about development of Districts as Export Hub as per desire of Hon'ble P. M of India and accordingly a District Level Export Committee is to be formed. She requested all Deptts, concern to submit write-up proposing potential export items. Also, G.M, D.I & C.C, Gauripur will take necessary follow-up action on the content of the letter and to prepare Action Plan.
- The DDC, Dhubri informed that the Next DISHA meeting will be held on 21<sup>st</sup> January'2020 and requested
  all concerned officials to submit Action Taken Report and Status Report immediately. Also, they were
  asked to attend the meeting invariably.

The meeting then ended with vote of thanks from the Chair.
