

MINUTES OF THE DDC MEETING HELD ON 05.02.2022 AT 11.00 IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Sri. Anbamuthan M.P, IAS, DC, Dhubri. He welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

Review of Schemes of different Departments :

1. HEALTH :-

The Joint Director of Health Services, Dhubri briefed the House on various schemes and monthly vaccination programme being taken up by the Health Department in the District.

On being queried about the status of Covid-19 vaccination in the District, the Joint Director of Health Services, Dhubri informed that the entire eligible population of 10,44,630 has been given the 1st dose of Covid vaccination (100%) except lactating mothers and other seriously ill people. He informed that till 27.01.2022 they have conducted 485871 nos. of COVID Test and out of which RAT Test conducted is 418149 nos. and RTPCR 67722 nos. As on date active cases in the District is 972 nos. and out of the above active cases 941 are in Home isolation. The Institutional Isolation numbered only 31.

The Deputy Commissioner, Dhubri requested the Joint Director of Health Services, Dhubri to give more effort to cover up vaccination of all eligible population including "Due" and "Over-Due" on Mission Mode.

Regarding immunisation, the Joint Director of Health Services, Dhubri assured that he will be able to cover up 90% plus target by the end of financial year. The Deputy Commissioner, Dhubri suggest for engagement of more officials in order to achieve the target.

2. P.W.D. BUILDING :

The E.E. PWD Building, Dhubri briefed the House on the progress of various schemes taken up by them. On query, he informed that as on date the progress of Dhubri Medical College is 87%.

The progress in respect of Model Residential School, Bilasipara is 97% and that of Model Residential School, Golokganj is 61%. Further, the E.E. PWD Building, Dhubri informed that all the works under MSDP 12th Plan entrusted to his division has been completed.

It was further informed by the E.E. PWD Building, Dhubri that construction works of Polytechnic College, Agomani and New Model Women College, Golokganj and Bilasipara are also hampered because of land settlement problem.

The Deputy Commissioner, Dhubri requested the E.E. PWD Building, Dhubri to step up for completion of all pending works. In case of land settlement problems, E.E. PWD Building, Dhubri was requested to take up the matter with the concerned Circle Officer and to sort out the problems.

3. AGRICULTURE :

The DAO, Dhubri briefed the house of different schemes being implementation in the District.

(i) NFSM, 2021-22 :- It was informed that 171 qtls. (Var : RH-04-06) of Mustard Seed Minikit and 13 qtls (Var : RGN -298) of Mustard Mini Kit has been distributed to the beneficiaries. Presently they are in vegetative stage.

(ii) BGREI :- The DAO, Dhubri informed that they have so far distributed 80 nos. of Power Tiller to the beneficiaries under BGREI, 2018-19 and 11 nos. of Power Tiller under BGREI, 2019-20. The distribution of remaining Power Tiller could not be takes place because of want of deposition of beneficiary share.

(iii) CMSGUY :- The District Agriculture Officer, Dhubri informed that they have distributed 324 nos. of tractors in Phase-I. Under Phase II, they have distributed 511 nos. of Tractors to different groups out of total 874 nos.

(iv) PM-KISAN :- It was informed that 19696 nos. of new application were received under the scheme and so far 15000 applications have been verified. Again, as on date 5830 nos. of new beneficiary have been uploaded in the portal till date.

4. P.W.D. RURAL ROADS :

The E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road division informed that out of targeted road length of 153.84 Km under PMGSY for the year 2017-18, 2018-19 & 2020-21, they have completed 46.54 Km.. Beside construction of 07 nos. of RCC bridges have been completed.

The House then reviewed the progress of roads taken up under BADP.

(i) Const. of Approaches road RCC Br. No. 2/1and 3/1 on old NH at 5t Km to IBB Road near Sonahat BOP, 2016-17 – Progress 92%. The E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road division informed that the work will be completed within 15 to 20 days .

(ii) Const. of CC block Road from Tistarpar PMGSY Road to Tistarpar BSF Camp – The work has been completed.

(iii) Const. of CC block road from Golakganj Soulhari road near Satsang to Ghoshpara with both side drain, 2018-19 – The work has been completed.

(iv) Const. of CC Block Road from Nalia Bazar to Berbhangi via NaliaPt-I, 2018-19 – Progress 70%. It was decided to complete the remaining portion of work by January, 2022 and to submit bill.

The Deputy Commissioner, Dhubri requested the E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road division to take steps to complete all on-going works of BADP by 10th of February, 2022 without fail and to submit bills for onward submission to the Govt. in Border Protection and Development department.

It was also resolved that a separate meeting with the E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road division will be held to review the progress status of the schemes.

5. PHE :

The Deputy Commissioner, Dhubri enquired about the progress of JalJeevan Mission and requested the E.E, PHE, Dhubri to take steps for timely completion of the scheme.

On query about providing Running Water facility to Schools and Anganwadis, the E.E, PHE, Dhubri informed that 876 nos. of schools have been provided with the Running Water facility out of 1873 nos. Further, proposal for approval and technical clearance in respect of another 541 schools have been sent to Chief Engineer's Office, Guwahati. Similarly, 588 nos. of AWCs have been covered out of 2169 nos. under Running Water Supply schemes. Proposals for covering another 525 nos. of AWCs have been submitted to Chief Engineer's Office, Guwahati for clearance.

The Dist. Development Commissioner, Dhubri informed that as per Govt. instruction henceforth Running Water to Schools and AWCs will be covered under JJM and as such she requested all other Heads of departments not to consider schemes on Drinking Water from their end.

6. EDUCATION :

The Deputy Commissioner, Dhubri requested the DEEO, Dhubri to take steps for construction and renovation of schools in char areas which are in very dilapidated condition.

The DMC, SSA, Dhubri informed that 62nos. of Const. of Additional Classroom and 33 nos. of Boys Toilet has been taken-up under RIDF 2020-21. Necessary fund in this regard has been released to the SMC on 16.12.2021.

The Inspector of Schools, Dhubri cum DPC, RMSA, Dhubri informed that the Ground Floor roof slab casting in respect of KulamuyaNichinpur High School under the scheme SamagraShiksha, 2019-20 has been completed. The remaining works are in progress. The Deputy Commissioner, Dhubri requested the Inspector of Schools, Dhubri cum DPC, RMSA, Dhubri to complete the scheme within the time frame.

7. DI&CC :

The F.M, D.I & C.C, Gauripur informed that out of 67 nos. proposals under PMEGP for the year 2021-22 they have received sanction against 66 nos. The sanction in respect of remaining one is likely to be completed before 31st March'2022.

Regarding the status of SVAYEM scheme, it was informed that the same has been closed since last two years from the Bank end and now the State Govt. is implementing the scheme from its own source.

8. WATER RESOURCE :

The E.E, Water Resources Division, Dhubri reported that at present one scheme viz. Anti-erosion protection works to protect Khonabari-Poninoyoni village and its adjoining areas on its R/B of river Tipkai under RIDF XXVI is under progress.

The E.E, Water Resources Division, Dhubri reported that Govt. of Assam is taking loan from Asian Development Bank for 09 nos. of protection works for which GOI has accorded approval. Among the 09 nos. of proposals, there lies the project of protecting Fakirganj to Hazirhat (23KM). He requested Chairman to take up with the concerned authority for getting it sanctioned in the first phase.

9. IRRIGATION :

The E.E, Irrigation, Gauripur informed that the Installation of Solar/ Electrical TWS under PMKSY-HKKP (100 Nos.) have been completed and commissioned. It was further reported that as on date 10 nos. of LIS /DTWS are in operating partially or fully to supply water to fields.

10. AH & VETERINARY:

The Dist. A.H & Veterinary Officer, Dhubri informed that the target for artificial insemination for the district has been fixed at 20,000 nos. and cumulative achievement of Calf Born till January'2021 is 4929 nos. Under Prevention of Livestock Diseases, the target is 1,91,000 doses and they have provided 25164 doses till last month. In case of Deworming of new born Calf, it was reported that so far 10399 nos. of Calf were taken care under the scheme.

11. FISHERY :

The I/C DFDO, Dhubri briefed the house on the progress of RIDF-XXIII ,RKVY, SOPD(SCSP), PMMSY and APART under implementation in the District. In case of RIDF-XXIII (GhoreGhorePukhuriGhoreGhoreMaach) Farmer's Individual Ponds, the I/C DFDO, Dhubri informed that as on date 323 nos. of construction works of new ponds have been completed out of targeted 435. Under APART, 2021-22, 03 nos. of FPGS has been engaged for Carp Polyculture Demo and 1 no. FPGS has been engaged for High Yielding Fish Seed Rearing Unit.

The DC, Dhubri requested the DFDO, Dhubri to follow the guidelines while implementing the schemes.

12. APDCL :-

The AGM, APDCL, Dhubri informed that new rural electrification works has been launched in the District under DeendayalUpadhyaya Gram Jyoti Yojana (DDUGJY) for providing electricity connection, both On-Grid and Off-Grid.

On query, the AGM, Dhubri Electrical Division, Gauripur informed that all the Transformers issued under MLA quota have been from Bongaigaon and most have been installed. As on date no transformers are left in respect of Bilasipara East and Bilasipara West LAC. In case of other LACs, few numbers of Transformers are available. However, 02(two) nos. of Transformers under MP quota is yet to be lifted from Bongaigaon.

On query regarding repairing of damaged Solar Project of Falimari G.P, the AGM, Dhubri Electrical Division, Gauripur informed that requisition in this matter has been submitted to the authority and it is expected the same will be repaired soon.

13. FOOD & CIVIL SUPPLIES :

The i/c Deputy Director, Food & Civil Supplies and Consumer Affairs, Dhubri, on query from the Chair, informed that as on January'22, altogether 12,26,849 population have been covered under NFSA/13. The total allocation of rice under NFSA Rice (Regular) has been fixed for the month of January/2022.

The Deputy Commissioner, Dhubri suggested for procurement of more Paddy as per Govt. rate (MSP) in compare to the last year purchase to help farmers from distress sale.

14. NABARD:

The DDM, NABARD, Bongaigaon requested all concerned Departments imparting schemes under NABARD, XXIV & XXV to complete the scheme and submit requisition for release of fund.

15. SOCIAL WELFARE :


The i/c DSWO, Dhubri informed that 66 nos. of beneficiaries has been forwarded to the Directorate for consideration under DeenDayalDivyangjanPunarSansthaponAchoni. He further informed that altogether 3816 nos. of beneficiaries has been selected and forwarded to the Directorate under DeenDayalDivyangjan Pension Scheme for the year 2019-20.

It was informed that under the scheme "Identification of persons with disability for issue of disability certificates", a total of 7 nos. of Medical Camp for Dhubri District for screening of persons with disability has been completed and 1947 nos. of disability certificates has been issued by the Joint Director of Health Services, Dhubri.

MISCELLANEOUS :-

1. The DDC, Dhubri requested the Deputy Director, FCS&CA, Dhubri and AGM, APDCL, Gauripur to provide a copy of BPL list to DRDA, Dhubri for their needful action
2. The DC, Dhubri requested all the heads of the Departments to submit their progress reports within 2nd of every month positively for timely compilation and placing them in the DDC meeting

The meeting then ended with vote of thanks from the Chair.
