

MINUTES OF THE DDC MEETING HELD ON 06.09.2021 AT 11.00 IN THE CONFERENCE HALL,
DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Sri. Anbamuthan M.P, IAS, DC, Dhubri. He welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

1. HEALTH :-

The Joint Director of Health Services, Dhubri briefed the House on various schemes and monthly vaccination programme being taken up by the Health Department in the District. He further informed that at present the Covid Vaccine is out of stock and it is expected to arrive soon.

The Deputy Commissioner, Dhubri informed that Hon'ble Chief Minister of Assam has directed to focus on certain areas like cleanliness in the Hospital Campus, streamlining of Ambulances etc. in the meeting held recently with Deputy Commissioners of Assam. Accordingly it was decided that Joint Director of Health Services, Dhubri will take steps for cleanliness drives in the all the Hospitals for maintenance of better hygienic conditions in the hospitals. It was also decided that DPO, Health, Dhubri will take steps for removing of all Private Ambulances from the Govt. Services.

Further, it was decided to start re-functioning of Canteen in the Dhubri Civil Hospital and for that it was suggested to convene a meeting of Civil Hospital Staff and discuss on the matter.

The Chairman requested the Joint Director of Health Services, Dhubri to take steps for closure of Pharmacies functioning in front of Dhubri Civil Hospital. It was also resolved that Drug Inspector will go for inspection of functioning of Atal Pharmacy and submit report.

The Deputy Commissioner, Dhubri directed the Joint Director of Health Services, Dhubri to prepare fresh estimate for construction of Paediatrics Ward of Dhubri Civil Hospital as the present estimate of Rupees 27 lakhs is too exaggerated.

2. FOOD & CIVIL SUPPLIES :

The Deputy Director, Food & Civil Supplies and Consumer Affairs, Dhubri, on query from the Chair, informed that there is sufficient stock of Rice in the District. The Deputy Commissioner, Dhubri suggested for procurement of more Paddy in compare to the last year purchase to meet up the demand.

Further, the Deputy Director, Food & Civil Supplies and Consumer Affairs, Dhubri informed that altogether 1121 nos. of Ration Cards have been surrendered till date and 4727 new Ration Cards have been issued to the beneficiaries.

The Chairman directed the Deputy Director, Food & Civil Supplies and Consumer Affairs, Dhubri to take steps for deletion of APL beneficiaries, not qualified for the benefits.

3. P.W.D. BUILDING :

The E.E. PWD Building, Dhubri briefed the House on the progress of various schemes taken up by them. On query, he informed that as on date the progress of Dhubri Medical College is 84%. The progress in respect of Model Residential School, Bilasipara is 96% and that of Model Residential School, Golokganj is 41%. He informed that due to land settlement problem the progress in case of Residential School, Golokganj is not up to the mark.

The Deputy Commissioner, Dhubri requested the E.E. PWD Building, Dhubri to step up for completion of all pending works. In case of land settlement problems, E.E. PWD Building, Dhubri was requested to take up the matter with the concerned Circle Officer and to sort out the problems.

Further, the Chairman directed the E.E. PWD Building, Dhubri to take steps for immediate start of the work of the New Polytechnic, Dhubri. It was also resolved that the A.E.E. PWD Building will take steps for starting construction of Community Hall at Satrasal under BADP as the land problem has been solved.

The Chairman requested the E.E. PWD Building, Dhubri to take action for gearing up the construction work of ISBT, Bilasipara as the progress is very low i.e. only 19%.

4. P.W.D. RURAL ROADS :

The E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road division informed that out of targeted road length of 47.932 Km, they have completed 46.676 Km under 2017-18 & 2018-19. At present the construction of balance work measuring 1.256 Km in addition to construction of 03 nos. of Bridges are in progress.

The House then reviewed the progress of roads taken up under BADP.

- (i) Const. of Approaches road RCC Br. No. 2/1 and 3/1 on old NH at 5t Km to IBB Road near Sonahat BOP, 2016-17 – Progress 92%. It was resolved to complete the work before next DDC meeting.
- (ii) Const. of CC block Road from Tistarpar PMGSY Road to Tistarpar BSF Camp – Progress 65%, 2016-17. It was resolved to complete the work before next DDC meeting.
- (iii) Const. of CC block Road from IBB road to Lakhimari Pt-III L.P School with 1 no. HP Culvert – Work just allotted. The Chairman directed to complete 50% of work before next DDC meeting and to complete the work by the end of October/2021.
- (iv) Const. of CC block road from Golakganj Soulmar road near Satsang to Ghoshpara with both side drain, 2018-19 – Progress 75%. It was reported that the work has been stopped because of land problem. It was decided that the Circle Officer, Golakganj alongwith the E.E. PWD, Dhubri Civil Sub-Division Dhubri, Territorial Road Division and concerned Contractor will visit the site tomorrow for necessary eviction and sorting out of problem.
- (v) Const. of CC Block Road from Nalia Bazar to Berbhangi via Nalia Pt-I, 2018-19 – Progress 30%. It was decided to complete 50% works by next DDC meeting and to complete the work by November/2021.
- (vi) Const. of CC Block road from Gaspara Gram Panchayat Office via South Gaspara to ferry Point/tent post, 2019-20 – Progress 50%. It was informed that the work has been stopped because of overlapping works. The Chairman requested the DDC, Dhubri to visit the site and sort out the problem.
- (vii) Const. of RCC bridge at Bhelakova- Durahati PWD Road to Singimari Pt-II under Durahati G.P, 2019-20 – Progress 80%. Instructed to complete the work before next DDC meeting.
- (viii) Const. of link Road with CC Block from IBB road to Kedar Pt-II near IBB fence, Gate No.44, Year 2019-20 – Progress 70%. To complete by next DDC meeting.
- (ix) Const. of CC Block Road from DK Road to Nh-31 via Morakura with 1 Box Cell Culvert, 2019-20 – Progress 60%. To complete by next DDC meeting.
- (x) Const. of CC Block Road from Uchita PWD Road to DK road via Dalbari, 2019-20 – Work Just Allotted. It was decided that 30% of works to be completed by next DDC meeting and 100% by the end of October'2021.

5. PHE :

The Deputy Commissioner, Dhubri enquired about the progress of Jal Jeevan Mission and requested the representative of PHE, Dhubri to take steps for early completion of the scheme. The A.E, PHE, Dhubri stated that DPRs of the scheme is yet to be submitted by the Consultancy. As informed by the officials of Consultancy Service, 50% of DPR will be submitted on 09th September and the remaining DPRs will be submitted on 11th September/2021.

The Chairman requested the A.E., PHE, Dhubri to complete the JJM works of South Salmara immediately. He also directed the A.E., PHE, Dhubri to convene a meeting of all S.Os on 07.09.2021 for a discussion on the matter.

6. EDUCATION :

The Chairman requested the Inspector of Schools cum DEEO, Dhubri to submit a report on schools being affected by the recent flood for his appraisal.

The DEEO, Dhubri informed that the entry of DISE code in the portal has been completed. However, the Assessment of the same will be done by the SSA.

On query, the Inspector of Schools cum DEEO, Dhubri informed that school at Nilokhiya is functioning without electric connection. The Chairman requested the Senior Project Associate, Assam Energy, WRI India to make a survey on schools having no electricity connection so that Solar Connection can be provided to such schools.

Further, the Senior Project Associate, Assam Energy, WRI India gave a briefing on the works of WRI India and informed that at present they will make a survey on Govt. Institution having no

electrification and on the basis of survey they will prepare a route map for taking up solar electrification of Govt. Institution on priority basis. He requested all the concerned departments for their cooperation in the collection of data.

The Inspector of Schools cum DEEO, Dhubri informed that the land problem in respect of construction of Kasturba Gandhi Balika Vidyalaya, Dharmasala is yet to be resolved. The Deputy Commissioner, Dhubri directed the Inspector of Schools cum DEEO, Dhubri to sort out the problem with PWD (Bld), Dhubri before next DDC meeting otherwise the school may be amalgamated with any other school, either in Dhubri Town or in Bilasipara Town.

7. DI&CC :

The GM, DI & CC, Gauripur briefed the House on the progress of different schemes taken by the Industry Department in the District.

On query from the Chair, the GM, DI & CC, Gauripur reported that all the Terracotta Furnace (Oven) has been constructed except one who is already having an advanced furnace.

The GM, DI & CC, Gauripur informed that the villagers of Debottar Hasdaha Pt-I have been involved in Wood Curving works and as such proposal may be submitted to the Govt. for upgrading the village as Wood Curving Cluster Village. The D.C, Dhubri agreed to the proposal.

The DDC, Dhubri suggested the GM, DI & CC, Gauripur to submit proposals of ex[port items available in the District beside Chilly for which District Administration has already taken initiative.

Further, the GM, DI & CC, Gauripur informed that the Govt. of India has asked to organise one day Export conclave in-between 24-26 September in the District and accordingly he requested D.C, Dhubri to finalised the date.

The Deputy Commissioner, Dhubri suggested the DAO, Dhubri to form Farmers Producer Organisation, Bilasipara to avail the benefits of schemes under Industry Department.

8. WATER RESOURCE :

The E.E, Dhubri Water Resource Division informed that the protection works at Binnachara under SOPD is under progress and so far about 90% works completed. Similarly, the works taken up under RIDF is likely to be completed by December/2021.

9. IRRIGATION :

While reviewing the schemes of Irrigation Department, the Chairman requested the E.E, Irrigation, Gauripur to share their irrigation Pin-Points with the Agriculture Department with a copy to him for verification by the Agriculture Department by their ADOs and the DAO, Dhubri will submit verification report for his appraisal.

10. SOCIAL WELFARE :

The i/c DSWO, Dhubri informed that the uploading of data on Pradhan Mantri Matri Vandana Yojana (PMMVY) is under Progress. The DDC, Dhubri requested him to gear up the up loading process as the same is very slow and suggested for a meeting with the Supervisors on the matter. It was also resolved that the i/c DSWO, Dhubri will submit the latest report on the progress of Pradhan Mantri Matri Vandana Yojana (PMMVY) by tomorrow. The Deputy Commissioner, Dhubri requested the SDO(Sadar), Dhubri to monitor the implementation of PMMVY in the District.

It was reported by the i/c DSWO, Dhubri that a Food Mela has been under way in Chapar and will continue upto 21.09.2021.

On query, the i/c DSWO, Dhubri informed that as on date 1492 nos. of Severe Acute Malnutrition Children (SAM) have been identified in the District and they have to be rehabilitated. The final list will be prepared by the third week of this month and after that rehabilitation process will start.

The Deputy Commissioner, Dhubri requested the E.E, PWD Roads, Dhubri/Bilasipara; E.E, PHE, Dhubri; Dy. Director F&CS, Dhubri; E.E, PWD Building, Dhubri; E.E Water Resource, Dhubri ; PD, DRDA, Dhubri in particular and other Departments in general to adopt such children. Besides, the Assistant Commissioners have been directed to personally monitor the matter alongwith CDPOs of Anganwadi Centres.

While reviewing the Poshan Abhiyaan, the Deputy Commissioner, Dhubri requested the i/c DSWO, Dhubri to take steps for successful observation of the Poshan Month in the District.

11. AGRICULTURE :

The DAO, Dhubri briefed the house of different schemes being implementation in the District.

- (i) MIDH :- It was informed that 10 nos. of Power Tiller will be distributed to the beneficiaries and in this connection collection of applications is under process.
- (ii) BGREI :- The DAO, Dhubri informed that they have so far distributed 80 nos. of Power Tiller to the beneficiaries under BGREI, 2018-19 and 11 nos. of Power Tiller under BGREI, 2019-20. The distribution of remaining Power Tiller could not be takes place because of want of deposition of beneficiary share.
- (iii) CMSGUY :- The District Agriculture Officer, Dhubri informed that they have distributed 324 nos. of tractors in Phase-I. Under Phase II, they have distributed 458 nos. of Tractors to different groups out of total 874 nos.

12. AH & VETERINARY:

The Dist. A.H & Veterinary Officer, Dhubri informed that the target for artificial insemination for the district has been fixed at 20,000 nos. and cumulative achievement of Calf Born till August'2021 is 2502 nos. Under Prevention of Livestock Diseases, the target is 1,91,000 doses and they have provided 11777 doses till last month. In case of Deworming of new born Calf, it was reported that so far 5692 nos. of Calf were taken care under the scheme.

On query from the Chair the Dist. A.H & Veterinary Officer, Dhubri informed that altogether 40,000 animals were affected by the recent flood. The Deputy Commissioner, Dhubri requested the Dist. A.H & Veterinary Officer, Dhubri to submit the list of Veterinary Buidings and Firms Circle wise within three days.

13. FISHERY :

The I/C DFDO, Dhubri briefed the house on the progress of RIDF, SOPD(SCSP), PMMSY and Paddy cum Fish Culture under implementation in the District. In case of Paddy cum Fish Culture, the I/C DFDO, Dhubri informed that the Govt. has been moved to for supply of Fish Seeds.

The Chairman requested the I/C DFDO, Dhubri to submit the list of Community Tanks, being constructed by them, with location for his appraisal.

14. HANDLOOM & TEXTILES :

The Assistant Director, H&T, Dhubri informed that under MUDRA Yojana, 2020-21 they have received target of 500 nos. and so far no sanctions has been received from the banks.

The Deputy Commissioner, Dhubri requested the Assistant Director, H&T, Dhubri to provide the list of beneficiaries by tomorrow to LDM, Dhubri for necessary follow-up action.

15. TOWN & COUNTRY PLANNING:

The Deputy Director, T&CP, Dhubri briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that under PMAY-HFU a total of 6125 nos. of houses have been completed and Geo-Tagged. He further informed that as per new guidelines the construction of houses under PMAY-HFU has to be completed within 120 days on receipt of approval.

MISCELLANEOUS :-

1. The Deputy Commissioner, Dhubri requested all concerned departments implementing P.M's Flagship Schemes to give priority on timely completion of the schemes.
2. The DDC, Dhubri requested all departments to submit their monthly progress reports in connection with DDC meeting on the last date of every month positively.

The meeting then ended with vote of thanks from the Chair.
