MINUTES OF THE DDC MEETING HELD ON 12.10.2020 AT 12.00 NOON IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smti. Banashree Nath, ACS, DDC, Dhubri. She welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

1. TOWN & COUNTRY PLANNING:

The Deputy Director, T&CP, Dhubri briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that under PMAY-HFU a total of 4372 nos. of houses have been completed and Geo-Tagged. Another, 1567 nos. of Houses has been completed but yet to be Geo-Tagged.

On query, the Deputy Director, T&CP, Dhubri assured that the construction works of PMAY-HFU houses taken up in the year 2017-18 will be completed by March2021.

2. AH & VETERINARY:

The Dist. A.H &Veterinary Officer, Dhubri informed that the target for artificial insemination for the district has been fixed at 22,000 nos. and cumulative achievement of Calf Born till September 2020 is 2854 nos. Under Prevention of Livestock Diseases, the target is 3,30,000 doses and they have provided 6317 doses till last month. In case of Deworming of new born Calf, it was reported that so far 6292 nos. of Calf were taken care under the scheme.

The Dist, A.H &Veterinary Officer, Dhubri requested the KVK, Bilasipara to submit the list of beneficiary getting ducks and other animals from their end under tribal distribution and other schemes to them for avoiding duplicacy.

3. PWD (Building):-

a) <u>BADP</u>:- Total schemes = 4 nos. Completed = 2 nos. Under progress = 2 nos.

The District Dev. Commissioner, Dhubri directed the E.E., PWD (Bldg), Dhubri to take steps for completing the scheme viz. "Const. of Cultural Hall at Sagolia Public Field near Sagolia Gate under Inter State Border Dev Activities ,2018-19 and. "Const. of Community Hall near BOP Kalaicharbari under BADP, 2017-18 (Central Share), the E.E., PWD (Bldg), Dhubri without any further delay and submit bills.

b) RMSA:-

- (i) The progress of the construction of (G+2) storied provision Digital Class Room and Digital Library at Alomganj Rangamati College, Alomganj is 91%. The Chairperson redquested the E.E. PWD (Bldg), Dhubri to direct the Contractor to complete the work within 07 days and submit the completion report.
- (ii) It was reported by the E.E. PWD (Bldg), Dhubri that the notice has been served to the Contractor to complete the work within October/2020 for the work viz. " Const. of Girls' Hostel at Mahesh Chandra Academy, Dumardaha.

The DDC, Dhubri requested E.E, PWD (Bldg), Dhubri and the Inspector of Schools to submit the list of Schools for which construction works were taken up by the School Management Committee by tomorrow for her appraisal.

The Chairperson requested the E.E. PWD (Bldg), Dhubri to remove the list of works which are completed from the main list submitted for review in the DDC meeting.

4. Water Resource Deptt :-

On query, the E.E, Dhubri Water Resource Division, Dhubri informed that the protection works are yet to be started as the water level is not yet decreased. He informed that the required materials for protection works are being dumped at the sites and as soon as the water level recedes, the protection works will be stared.

5. SOCIAL WELFARE :-

- 287
- (i) ICDS Scheme: The DSWO, Dhubri informed that fund has been released to 1781 nos. Main AWCs and 338 nos. of Mini AWCs for 14 days under Hot Cooked Meal (HCM) for the month of September 20202.
- (ii) Pradhan Mantri Matru Vandhana Yajana (PMMVY):- It was reported that till date, altogether 65,448 nos. of beneficiaries have been uploaded and 56,457 nos. of beneficiaries have received fund. At present 7,075 nos. of beneficiaries are pending for payment after rejection of 1956 nos. of applications.
- (iii) One Stop Centre for Women: The DSWO, Dhubri stated that the One Stop Centre in Dhubri is presently functioning temporarily at Destitute Home, Dighaltari and a NGO named Aman Kachru Trust" is looking after the day to day functioning of the Centre. Land possession for construction of the Centre at Madhusoulmari Pt-II has been taken and the construction work will start soon.

6. AGRICULTURE :-

The DAO, Dhubri briefed the house of different schemes being implementation in the District.

- (i) Procurement of Paddy: The DAO, Dhubri, reported that 2907.6 MT paddy has been procured by FCI, Balajan till date. The procurement by the DDRMC and NAFED are yet to be started.
- (ii) KCC:- The DAO, Dhubri informed that till date 460 nos. of KCC applications have been sponsored to the Banks for sanction.
 - The LDM, Dhubri informed that SBI, Dhubri has reported of 1022 nos. of NPA cases and has initiated Bakijai cases against them. He informed that the list will be provided to DAO, Dhubri and requestim to take action for recovery of the loan utilising their field functionaries.
- (iii) The DAO, Dhubri informed that the under PMFBY,2020-21, Insurance has been done covering 29189 nos. of farmers with an area insured for 12119.38 Hectare for different crops like Black Gram, Jute and Sali Paddy.

7. Agril. Engineering :-

On query, the E.E. Agril, Gauripur reported that as informed, the fresh DLAC will be constituted by the higher authority soon. He informed that before release of fresh instalment he has been asked by his higher authority to cause enquiries of earlier released instalments done by his predecessors.

In case of distribution of Power Tillers, it was reported that the same will be done soon.

8. Kissan Vikash Kendra :-

The SMS, KVK, Bilasipara informed that the Project for mushroom growing in Tribal areas has been taken up and in this connection training and demonstration will be conducted soon.

He further stated that the distribution of ducks to tribal people will start from today.

9. PHE:-

The E.E., PHE, Dhubri informed that the Geo-Tagging of 147173nos. of IHHL out of 147251 (99.95%) for 2020-21 under Swachh Bharat Mission (G) has been achieved.

On query from the Chair, the E.E. PHE, Dhubri informed that under LOB (Phase-I), 5741 nos. of IHHL out of targeted 5800 nos. have been completed. Similarly, a total of 4373 nos. of IHHL out of targeted 24454 nos. have been constructed till date under the scheme NOLB (LOB-Phase-II)

10. AUS&SB :-

The representative of E.E. AUS&SB, Dhubri informed that the Dhubri Water Supply scheme has been commissioned and is now under operation and maintenance. At present 724 household are enjoying the benefit of the scheme.

11. IRRIGATION

The E.E. Dhubri Division Irrigation informed that working estimate submitted to the higher authority has been approved in respect of scheme viz. "Renovation of Asharikandi L.I.S.(Ph-II)

under SOPD-SCSP. He assured the house that the scheme will be completed by 31" March 2020.

On query, it was informed by the E.E. Dhubri Division Irrigation that joint verification of schemes in respect of Agomani and Golokganj Dev. Block has been done.

12. COOPERATION :-

The DDC, Dhubri requested the DRCS, Dhubri to guide the management of registered Societies to get their accounts verified by his officials. He was also requested to render necessary guidance to the Societies in this regard.

13. LOCAL AUDIT :-

The Assistant Director of Audit (Local Fund), Dhubri informed that at present audit of accounts of CEO, Zila Parishad is under progress. The audit of Nazarat Branch of Dhubri D.C's office will be taken up later on. Besides, the audit of all the blocks of Dhubri District and S/Salmara-Mankachar District has been done.

The Assistant Director of Audit (Local Fund), Dhubri further informed that the Govt. has sanctioned fund for construction of the Office building of Local Audit of Dhubri District and for this he requested for allotment of land in and around Dhubri Municipality area.

The Chairperson suggested him to contact ADC (Revenue), Dhubri for allotment of land.

14. FCS & CA :-

The representative of Dy. Director, FCS&CA, Dhubri informed that the distribution of Mid-Day Meal rice is going on smoothly and in this connection the payment of bills to FCI has been done. As on date no pending bill of FCI is lying with them.

15. IWT :-

The DDC, Dhubri request the Junior Engineer, IWT, Dhubri to go for checking of registration and seizing of unofficial boats plying in the river Brahmaputra in the District.

The Junior Engineer, IWT, Dhubri informed that from today SDO level Office will start functioning in the District for the benefit of public.

16. NABARD :-

The Manager, NABARD. Assam informed that different schemes are under progress in the District and accordingly wants to know about the progress from different executing agencies. The DDC, Dhubri suggested for a separate meeting with Departments and Bankers to discuss on the schemes taken-up under NABARD for greater interest of public.

It was resolved that the District Administration will pursue with the higher authority of NABARD for permanent posting of an Officer in the District for smooth implementation of different schemes of NABARD in the District.

The E.E, PWD (Bldg), Dhubri informed that the Construction works of the Sapatgram Amalgamated Academy under NABARD for Rs.5.00 Crore will start soon. The DDC, Dhubri directed him to ensure completion of the work within stipulated time.

17. LEGAL METROLOGY :-

The Asstt. Controller, Legal Metrology, on query, informed that altogether 3 nos. of Weighing Bridge are functioning at International Trade Centre, Lakhimari. Out of these three, two nos. Weigh Bridge are run by the Govt. of Assam and one no. belongs to private party.

The DDC, Dhubri requested the Asstt. Controller, Legal Metrology to ensure electronic generation of bill at the Weigh Bridges which are operating at the ITC, Lakhimari.

18. ADULT EDUCATION :-

The DAEO, Dhubri informed that they have received a list of 30 persons belonging to Tiamari Pt-II from the CRPF for imparting education. He informed that at present no study material is available with them for imparting education. The Chairperson suggested him to contact CEO, Zila Parishad, Dhubri for providing materials if any left under the scheme "Shaskar Bharat".



19. ITI :-

The Superintendent, ITI, Panbari informed that online admission is going on for different trades for the current academic year.

The DDC, Dhubri suggested him to submit a detail report on the matter for appraisal of the District Administration.

20. SALES TAX :-

The Chairperson requested the Assistant Commissioner of Taxes, Dhubri to ensure action on the Power Loom Gamochas and on transportation of BIDIs from the District. In this connection necessary support from the Police, H& T, DI&CC may be taken.

21. RSETI :-

The Director, UCO RSETI, Dhubri informed that the training for Dairy Farming and Vermi Compose has been started with 50% capacity as per Govt. instruction.

It was further informed that the training to the PMEGP candidates couldn't be provided as the MOU has been expired. The DDC, Dhubri suggested him to consider such candidates as general and arrange for their training.

22. DAIRY :-

Copy to:

The Dairy Development Officer, Goalpara informed that Govt. has taken up scheme for conversion of informal Dairies into formal dairies through training and for this three nos. of Veterinary doctors are engaged for imparting training to the farmers.

INTER-DEPARTMENTAL :-

- It was unanimously resolved that the higher authority of the NABARD be moved for posting of regular official to Dhubri District as the District is an Aspirational District.
- The LDM, Dhubri requested officials for opening of Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and also to encourage others for go for the same.

The meeting then ended with vote of thanks from the Chair.
