The meeting was presided over by Sri. Dibakar Nath, IAS, Deputy Commissioner, Dhubri.

The Chair welcomed all the present members in the meeting and started department wise discussions.

Prior to initiate discussion the Chairman informed all the officers about the importance of having separate identity of the Asharikandi village which is famous for its traditional crafts, Teracotta & Pottery. He stated that it is one of the largest clusters of Teracotta in India. The Assamese Teracotta art & culture took its birth at this village wherein more than 100 cluster of pottery families are engaged in this ethnic art who depend their livelihood after selling upon these handicrafts items & it receives applauds in the National as well as in the International markets

The District Commissioner therefore requested all the heads of development departments to provide support through introduction of Govt schemes for infrastructural development of this area as well as for the preservation and promotion of the traditional craft and welfare of the craft persons. He asked all the officers to make a roam in and around the cluster & visit the artisans' cottages with full of traditional products to have a glimpse of making of Terracotta and can also buy them that will certainly encourage the poor artists.

DC stated that the connection with the river Brahmaputra through the Gadadhar, a tributary of mighty Brahmaputra, gives the place an advantage for Tourism attraction with marketing network with the major cities.

With a view to provide the basic infrastructure facilities for the Asharikandi Teracotta village areas & for the welfare of the crafts-men of this cluster, DC asked all the officers of development departments to assess the needs & submit the plan of action immediately for which they can make any future correspondence with the GP President of Asharikandi GP & some of the Senior crafts-men of the village.

He also interacted most of the beneficiaries in respect of proposed project, location of the Unit and other necessary documents. 
