# MINUTES OF THE DDC MEETING HELD ON 21.01.2023 AT 2.00 PM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided by Smti Kanta Das, ACS, District Development Commissioner, Dhubri. At the outset, she welcomed all the members present in the meeting.

Thereafter, the District Development Commissioner reviewed the departments as follows:

#### 1. AH & VETERINARY:

In a query from the Chair, DVO stated that under the Foot & Mouth Disease (FMD) control programme 30,422 nos. of animals have been covered out of 57,935 target in this month. Regarding fodder cultivation scheme, DVO informed that the department has received required applications against the target of 200 nos. of farmers and approval is in process. DVO also informed the house that he has intimated the issue regarding animal tagging to the Deputy Commissioner, Dhubri in black & white for initiating necessary action which was raised in the previous DDC meeting.

## 2. FISHERY:

In a query from the chair regarding RIDF (Ghare Ghare Pukhuri Ghare Ghare Maach) scheme, the DFDO stated that the department has completed the target of the scheme.

#### 3. <u>SOCIAL WELFARE</u>:

DPC, Social Welfare, Dhubri informed the house that as discussed in the previous DDC meeting the department has submitted a list of 100 nos. of Anganwadi centres in the district which require minor repairing to the Directorate of Social Welfare, Assam.

On the matter of arrangement of a disability camp, he stated that they have started conducting the disability camp on weekly basis in the premises of different blocks in the district.

#### 4. <u>EDUCATION</u>:

Referring to a discussion of the previous DDC meeting regarding Electrification of School, AGM, APDCL informed the house that tendering has been done and it is expected that Electrification process will be completed by next month.

#### 5. WATER RESOURCES:

While reviewed the status of acquisition of land for a project at Fakirganj area funded by ADB, the E.E., Water Resources, Dhubri informed the house that they have communicated with the concerned C.O. in this regard and survey is in process.

#### 6. P.W.D. (BUILDING):

The matter of delayed completion of different infrastructure works taken up at Madhupur Sattra was strongly reviewed. In reply, E.E. PWD (B) appraised the house that the concerned contractor has speed up the process and it is expected that the work will be completed by March, 2023.

On query regarding construction of a new Polytechnic at Agomani, E.E. PWD (B) requested the Chairman for possession of a new land which is free of any encroachment and resolve the land dispute created by a lady as discussed in the previous DDC meeting so that boundary walls could be completed after proper demarcation of the land. The Chairperson directed E.E., PWD (B) to communicate with the concerned C.O.

The E.E. PWD (B) informed the chair that possession of additional 10 bighas of land is required for construction of playground at Bilasipara Women College Campus. In reply, the chair instructed E.E., PWD (B) to communicate with the concerned C.O. in this regard

#### 7. APDCL:

On a query regarding the land issue of ongoing construction of a control room of APDCL at the premises of BDO Office, Dharmasala, the AGM, APDCL informed the house that the matter has been resolved.

### 8. <u>MISCELLANEOUS</u>:-

- (A) Sri Pradeep Das, the monitoring Officer of different departmental scheme in the district from T&D Department was also present in the meeting and he emphasized on timely completion of the schemes. He also suggested all the HODs to instruct the concerned technical person of the schemes to display the signboard in Assamese.
- (B) Dr. Akhtarul Islam, Associate Professor of Pramatesh Barua College, Gauripur delivered a presentation on <u>Gunotsav :: 2023</u>. ADC (Edu), Dhubri seeks full cooperation from all the officers present in the meeting for grand success of <u>Gunotsav :: 2023</u>
