

Notice Inviting Tender

For

PROVIDING ONE AMBULANCE FACILITY FOR BPHC IN DHARMASALA,8-DHUBRI LAC UNDER MPLADs FUND FOR THE YEAR 2024-25 IN RESPECT OF DHUBRI DISTRICT.

1) In pursuance with the notification vide no. DPD.302/2024-25/MPLADs/Misc/23, The District Transport Officer, Dhubri invites sealed quotation for supplying and commissioning one number of ambulance of Basic Life Support standards for BPHC in Dharmasala, 8- Dhubri LAC under MPLADs fund for the year 2024-25 in respect of Dhubri district from the authorised dealers in prescribed manners after satisfying the below mentioned technical specifications and terms and conditions. The important dates regarding the tender are mentioned below.

2. Tender should be submitted by hand or send by registered post to "The District Transport Officer, Dhubri" superscripting on the top of the envelope "Notice inviting quotation for providing one ambulance facility for BPHC in Dharmasala, 8- Dhubri lac under MPLADs fund for the year 2024-25 in respect of Dhubri district; not to be opened before 03:00 pm on 25-02-2025 at Conference Hall of DC, Dhubri." Quotation not accompanied by specified documents, self-declaration, signature, may be rejected by the office as non-responsive and may not be evaluated further.

3. The sealed Envelope is to be put inside the drop box which is kept on the Office of the DTO, Dhubri. The office shall not be held responsible for late delivery of the bid document.

**Terms and Conditions:**

1. This NIT is called for for providing one ambulance facility for BPHC in Dharmasala, 8- Dhubri lac under MPLADs fund for the year 2024-25 in respect of Dhubri district.

2. The tender inviting authority reserves the right to accept or reject any or all the tenders to be received without assigning any reasons thereof.

**3. Technical specification of the vehicle:**

The ambulance will adhere to the Basic Life Support (BLS) standards and include the following:

**a) Vehicle Specifications:**

- Chassis Make/Model : High-roof van (Force Traveller, TATA Winger, Mahindra Supro, etc.)
- Engine : Diesel, BS VI compliant
- Fuel Tank Capacity: Minimum 40 Litters
- Seating capacity : Driver+ 3 medical staff+ 1 patient on stretcher
- Transmission : Manual
- Air Conditioning : Factory-fitted AC for driver Cabin
- Power supply : Adequate battery and inverter system to support medical equipment
- Dimension:
  - Overall Length : 4800-5200 mm (approx.)
  - Overall width : 1800-2000 mm (approx.)
  - Overall Height : 2000-2300 mm (approx.)
  - Wheelbase : 2800-3000 mm
  - Ground Clearance : 160-220 mm

**b) Medical Equipment:**

- Patient Stretcher : Foldable, lightweight, and corrosion-resistant stretcher with locking system and safety belt for patient transport.
- Oxygen Cylinder : Medical-grade Oxygen cylinder ( D-type or equivalent) with Oxygen flowmeter, regulator, tubing, humidifier, and mask.
- Suction Apparatus : Portable, manual/electric suction pump
- Ambulance Chair : Foldable paramedic chair
- IV Hook : Stainless Steel, ceiling-mounted
- First Aid Box : Standard emergency medical kit (bandages, antiseptics, and wound care items)
- Patient bed : Fixed bed with a comfortable mattress for patient stability
- Attendance seats : 3 seats for medical attendants, ergonomically designed with seatbelts
- Defibrillator with monitor
- Nebulizer machine
- Glucometer and BP monitor
- Thermometer (digital)



**c) Basic Life-Saving Equipment:**

- Manual resuscitator (Ambu bag) with masks of different sizes
- Spine board with straps for immobilization, Basic airway management device (oropharyngeal airways)

**d) Communication System:**

- GPS tracking system for real-time monitoring, Wireless communication devices, Fire-safety measures (fire extinguisher included).
- High-visibility reflective decals and siren with public address (PA) system for emergencies First Aid and Safety guidelines displayed inside the ambulance.

**e) Electrical and monitoring System:**

- Siren and Public Address System : Standard Ambulance Siren with external mic.
- Flashing Light : Roof-mounted LED beacon lights (red/blue)
- Battery backup : Auxiliary battery for medical equipment
- Charging Ports : 12V DC for medical devices

**f) Other Provisions:**


- Interior lighting for day/night visibility for medical interventions
- Fully insulated interiors with washable panels
- Anti-skid flooring, fire-resistant, easy to clean vinyl flooring
- Storage compartments for medical equipment
- Proper Ventilation
- Noise and vibration dampening system
- Hand-held fire extinguisher (ABC Type, 2kg) for vehicle safety

**4. Estimated Costs:**

The Estimated cost for procuring the ambulance is **Nine Lacs** only. ( Rs. 9,00,000.00)

**5. Conditions for Bidders:**

- i) The bidder must have valid authorised certificate from the manufacturer.
- ii) The bidder should not quote the rate above estimated project cost. In the event of excess cost, the said quotation will be summarily rejected.
- iii) The bidder must submit the detailed technical specifications and make and model in compliance with the requirements for which the bid is submitted.
- iv) The bidder must provide the plan/arrangement for supply and warranty services to be provided at service centres in Dhubri.
- v) The bidder has to provide servicing and warranty facility against the said vehicle.
- vi) The bidder has to submit the copies of authorisation dealership certificate from the concerned manufacturer, PAN card, GST registration, IT Returns for last three years and current bank account details.
- vii) The quoted rate of the said vehicle must be inclusive of all taxes and must be FOR at site delivery.
- viii) The payment of the said vehicle will be released only after obtaining satisfactory commissioning and fitness certificate of the vehicle from the concerned authority.
- ix) NIT documents with seal and signature along with supporting documents with seal and signature should be part of the tender submitted.
- x) Failure to submit information required in this NIT or submission of tender not responding to this NIT, will be at the bidders' risk and responsibly and the same may finally lead to rejection of tender.
- Xi) The successful bidder must brand the ambulance with the following text on the body of the ambulance, "Ambulance Purchased with Government of India, MPLADs funds, 2024-25 contributed by Hon'ble Rakibul Hussain, Member of Parliament, Lok Sabha (Dhubri)."
