Candidate must bring duly filled up **STANDARD FORM OF APPLICATION** along with self attested photo copies of all documents relating to educational qualification, experience (if any), age, address proof, two passport size colored photographs, valid employment exchange registration certificate. Candidates must also bring all original documents for verification.
5. The candidates primarily selected after the Walk-in-Interview shall have to undergo handwriting and typing Test, in both English and Assamese language for the post of copyist likewise a computer skill test shall be conducted for the post of Data Entry Operator.
