# MINUTES OF THE DDC MEETING HELD ON 11.08.2022 AT 11.00 AM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smt. Kanta Das, ACS, District Development Commissioner, Dhubri. She welcomed all the Officials present in the meeting.

Initiating the discussion the chair asked all the HoD to take necessary action to fulfil the mismatch of targets in CM dashboard before the next DC's Conference scheduled to be held in the month of December 2022 and directed all the HoD to upload their monthly data in-between 25<sup>th</sup> day of every month.

Thereafter, the chair reviewed the following departments:

#### 1. Excise:

On query from the chair, the Superintendent of Excise informed the house that the department will able to upload the data in CM dashboard on the last day of every month as they are needed to compile the data for the part of Bilasipara Divn also. The chair requested SDO(C) Bilasipara to get in touch with the Bilasipara Excise Divn. in this regard.

## 2. Housing & Urban Affairs:

The Chair informed the house that the performance of Housing & Urban Affairs in the district against CM dashboard target is not satisfactory. The Chair requested Executive Officers of Dhubri Municipality Board, Gauripur Municipality Board & Golakganj Municipality Board to physically verify the houses of the beneficiaries to spot the actual picture.

# 3. Education:

During review of Education Department the I.S., Dhubri informed the house that they had submitted a requirement list of approximately 14,000 fans, 72 nos. of Girls Toilet in different categories of schools in the district. However, after D.C.'s Conference held in the month of July, CM has announced that this requirements will be managed by the donation of alumni of the respective schools and DEEO office has already sent letters to the respective schools in this regard. The Chair asked the IS, Dhubri to request local MLA, SMC for donation and ensure increase the nos. against target of CM dashboard. The Chair also made an appeal to all the HoD present in the meeting to donate fans in the schools. SDO(Civil), Bilasipara raised an issue of disconnection of power in many schools by APDCL due to overdue of Electricity bills. In reply SDE, Dhubri ESD, APDCL informed that waiver scheme may be availed to resolve these issues. The Chair asked the IS, Dhubri to prepare and submit a list of such schools.

## 4. Agriculture:

On query from the Chair regarding formation of FPO, DAO, Dhubri informed that out of 16 nos. of FPO, 4 nos. have completed its registration and 6 nos. are in process. The Chair instructed the DAO, Dhubri to ensure registration of atleast 2 or 3 nos. of FPO in the dashboard before end of this month. The Chair also asked DAO, Dhubri to expedite the process and asked to convene a separate meeting by the end of this month to review the status.

#### 5. Social Welfare:

On query from the Chair regarding SAM/MAM children, the Dist. Coordinator, Social Welfare, Dhubri informed the house that the data reflected on CM dashboard are based on National Family Health Survey 5 and the target shown in the dashboard is not justified to identify in one year. The Chair directed the officer to assess actual data and send mail to the State for its reconcillation.

## 6. Animal Husbandry & Veterinary Department:

District A.H. & Veterinary officer, Dhubri stated that Brucellosis Vaccination Drive has been started from 1<sup>st</sup> August and it will be conducted in three phases. He also added that in the 1<sup>st</sup> phase, the department has completed approximately 3000 nos. vaccination out of 13023 nos. He also requested representative of APDCL present in the meeting to ensure uninterrupted power supply at the veterinary Hospital to avoid damage of vaccines for proper cooling system.

#### 7. Fishery:

On query from the Chair, regarding "Ghare Ghare Pukhuri Ghare Ghare Maach" scheme, the DFDO, Dhubri informed the house that there are 387nos. of approved beneficiaries under Farmers individual pond section and out of which 307 nos. have completed upto 100%, 74 nos. have completed more than 50% and 4 nos. have completed less than 50%. The Chair expressed concern about the failure of achieving targets of the scheme after a lapse of 3 years or more. The chair asked DFDO, Dhubri to give details about transaction of funds to the beneficiaries and lodge FIR against the individual who has not started their work after receiving more than 50% of the funds. The Chair also directed the DFDO Dhubri to complete the construction of unfinished village community tank within 3 months.

# Health & Family Welfare:

The Joint Director of Health Services raised the issue of pathetic health infrastructure in Fakirganj area and informed the house that there are only 10 medical officers who have been rendering services among nearly 3 lakhs population of that area. He also added that though Airkata Health & Wellness Centre has the highest institutional delivery in the district in the last quarter but the MMR is quite noticeable. In this regard, he briefed the house that lack of infrastructure, high illiteracy rate etc. are the key reasons. He also requested representative of APDCL present in the meeting to resolve the electrification issue at the Meditary State Dispensary.

The meeting ended with a vote of thanks from the chair.
