

Minutes of the Meeting held on 17/01/2024 at 04:00 PM with the Recognised & Registered National/State Political Parties in connection with Special Summary Revision of Photo Electoral Roll-2024
In the Office Chamber of the Election Officer, Dhubri

Members Present – As per Annexure-A

The meeting was presided over by Sri Masi Topno, ACS, Election Officer, Dhubri. He welcomed all the members present and stated that this meeting with all Political Parties has been convened as per instruction of the Chief Electoral Officer, Assam to discuss the issues relating to the status and progress of the on-going Summary Revision works and further informed that the same will be held on every Wednesday at 04:00 PM till completion of the Summary Revision process. He further informed that the extended date of submission of all claims and objections relating to Form-6, 7 & 8 have been completed on 14/01/2023.

The Chairman also briefed the house about the status of submission and disposal of Form-6, 7, 8 and PSE & DSE in respect of 3 (three) nos. of LACs under Dhubri Election district till 17/01/2024 and stated that the performance of Dhubri Election District is so far satisfactory in terms of new enrolment and deletion of Dead/Shifted voters.

The Chairman further stated that Format 9, 10, 11, 11A & 11B which are related to claims and objections have handed over been to all Political parties and acknowledgement receipt has been taken.
