With reference to the subject cited above, I have the honour to inform you that the Hon'ble State Cabinet in its meeting held on 13th September 2024, has accorded approval to cover **19,92,167** (Nineteen Lakh Ninety Two Thousand One Hundred Sixty Seven) new eligible beneficiaries under NFSA in the state. All the newly selected beneficiaries will be included under **Priority House Hold (PHH) category**.

As suggested by the Hon'ble Chief Minister, **1,00,635 nos.** of beneficiaries have been kept in **State pool as reserve**.

The remaining **18,91,532 nos.** of beneficiaries have been allotted to the districts on the basis of **no. of LACs present in each district and taking into consideration 1,63,532 nos. of inadvertently deleted NRC beneficiaries** (as reported by the districts) to the concerned districts.

Accordingly, the district wise **number of new beneficiaries to be added** by the concerned districts in Ration Card Management System (RCMS) database has been worked out and enclosed herewith at **Annexure I**.

The District Commissioners may allot LAC wise beneficiary proportionately or in an equitable manner among the LAC depending on the Socio Economic condition of the LAC.

In view of the above, you are requested to take urgent necessary steps for **completion of the entire activity of Selection, data entry & approval of the new beneficiaries in RCMS database and writing of ration card by 15th November 2024** so that the selection process of these new beneficiaries could be sequenced suitably with **Orunodoi 3.0** programme.

Moreover, financial assistance will be provided to the districts @ **Rs. 20/- per beneficiary for making data entry** and @ **Rs. 10/- per ration card for writing of new ration cards**.

The detailed **guidelines for selection of new beneficiaries and entry** of the same in RCMS database, **Timeline for the entire activity** and list of **actionable points for districts** is enclosed for your reference at **Annexure II, III & IV** respectively.

Annexure II

Guidelines to be followed while issuing new ration cards and making new entry in Ration Card Management System (RCMS)

- 1) The selection of new beneficiaries must be according to the relevant rules and selection procedure mentioned in "The Assam Food Security Rules, 2022" (as amended).
- 2) The Income criteria to be eligible for selection as NFSA beneficiary will be as stated in the relevant rule of "The Assam Food Security Rules, 2022" (annual income of less than Rs 4 lakh per family)
- 3) State Government Muster Roll employees and Daily Wage earners, Retired Grade - IV employees of Central and State Government and contractual employees having annual family income of less than Rs 4 Lakh per annum are also eligible for selection as per latest amendment of The Assam Food Security Rules, 2022"
- 4) The Selection and finalization of beneficiary list must be made on Antodaya approach (the poorest of the poor must be given priority).
- 5) Priority should be given to those families with Annual family income of less than Rs. 2 Lakh
- 6) All the new beneficiaries to be selected will be under Priority Household (PHH) category only.
- 7) The Districts / Autonomous Councils must ensure that only genuine and eligible beneficiaries are selected and accordingly digitized in RCMS.
- 8) District Commissioners may allot LAC wise beneficiary proportionately or in an equitable manner among the LAC depending on the Socio Economic condition of the LAC.
- 9) In case of selection of new beneficiaries, priority may be given to inadvertently deleted NRC beneficiaries. However, they must submit duly filled C-forms along with all necessary documents and Aadhaar number for new selection.
- 10) The data entry of ration card / beneficiary details must be as per the information provided in the relevant documents submitted by selected beneficiaries.
- 11) No eligible beneficiary mentioned in the form 'C' by the eligible applicant should be left out from digitization.
- 12) Any data entry of selected beneficiaries done during the previous drive of addition of 40 Lakhs beneficiaries but pending for approval may be approved under this drive after due verification. Any approval under such cases will be within the given district wise / constituency wise beneficiary cap.
- 13) All the information entered in the database must be error-free and in full. No abbreviation or initials to be entered.

- 14) All the data entry must be done under strict supervision and monitoring of the respective Area Officers of FPD&CA and should not be left only to the data entry operators. All concerned officers must ensure correctness and accuracy of the beneficiary details.
- 15) Any outsourced person if engaged in data entry work must be engaged taking necessary undertaking from him/her regarding duties & responsibilities.
- 16) For data entry, financial assistance will be provided @ Rs 20/- per new beneficiary.
- 17) Concerned Officer of FPD&CA will be personally responsible for all activities carried out in Ration Card Management System through any Inspector ID/AFSO ID in case of his/her User IDs used by any other person.
- 18) Necessary technical support as and when required will be provided by NIC. NIC Assam team is also requested to nominate a dedicated Nodal officer for the process of data entry and approval of the new beneficiaries in RCMS under this special drive.
- 19) While issuing the new ration cards, the system generated unique ration card number from RCMS must be written correctly in the specified column of the ration card.
- 20) For Ration card writing financial assistance will be @ Rs 10/- per ration card
- 21) All districts must conform to the new legislative assembly constituency wise (new LAC wise)/ district wise population cap fixed and enclosed herewith at **Annexure V**.
- 22) The revised population cap is inclusive of all beneficiaries newly approved by the concerned authorities on or after the issue of this guideline.
- 23) While entering beneficiary details, the data in the beneficiary's Aadhaar Card must be taken into consideration in case of any mismatch
- 24) While entering beneficiary details, all necessary details of the beneficiary must be entered completely along with valid phone number.
- 25) Modification of ration card details & Deletion of ineligible / duplicate / death beneficiaries should go on simultaneously to ensure error-free data.
- 26) In case of any violation to the above, the concerned officers of FPD & CA will be made personally responsible.
- 27) Each district/subdivision will nominate a dedicated Nodal Officer not below the rank of Assistant Commissioner for the entire exercise.

Actionable points for districts

- To depute a Nodal Officer not below the rank of Assistant Commissioner for the entire activity.
- To depute dedicated officers from FPD&CA/Other Departments block wise to coordinate with all stakeholders for smooth and successful selection process.
- To strictly adhere to the norms and guidelines of selection of eligible new beneficiaries as per "The Assam Food Security Rules 2022" (amended up to date)
- To carry out both the selection and data entry process simultaneously to complete the entire exercise within the given timeline
- To start the data entry exercise in a designated location under the supervision of dedicated officer.
- To engage sufficient manpower for data entry exercise taking necessary undertaking from the outsourced manpower engaged for the purpose.
- To make mass publicity campaign among people regarding the selection process and eligibility criteria.
- District Commissioners may allot LAC wise beneficiary proportionately or in an equitable manner among the LAC depending on the Socio Economic condition of the LAC.
