PUBLIC NOTICE


It is for information to all concerned that the Food Corporation of India (FCI) has issued a notification regarding the sale of rice under the Open Market Sale Scheme (Domestic) [OMSS(D)] for the year 2025-26 for a quantity of 159 MT for Dhubri district. Under this scheme, small private traders, entrepreneurs, and individuals having valid GST registration in Assam are permitted to purchase a minimum of 1 Metric Tonne and up to 9 Metric Tonnes of rice per week per region directly from the FCI depots in Assam at the fixed reserve price of Rs.2800/- till 31/10/2025 & at Rs.2890/- w.e.f. 1/11/2025 onwards.

The most significant feature of this scheme is that interested buyers from Dhubri district can procure rice directly from the FCI depots without participating in the e-auction process. The procedure has been simplified to encourage maximum participation, and allotments shall be made on a first-come, first-served basis at the FCI Divisional Office Kokrajhar on all working days.

In order to facilitate maximum participation from the district, all eligible traders, entrepreneurs, and individuals are hereby requested to avail this opportunity and purchase rice under this scheme as per the guidelines issued by FCI. The detailed terms and conditions, application format, and depot-wise allocation details are available on the official websites of FCI at [www.fciweb.nic.in](http://www.fciweb.nic.in) and [www.fci.gov.in](http://www.fci.gov.in). These details may also be obtained from the office of the District Commissioner, Dhubri during office hours.

This public notice is issued in the interest of all concerned to ensure extensive awareness and to facilitate smooth implementation of the scheme in the district.


