**SUBJECT: DRAFT PUBLICATION OF PANCHAYAT ELECTORAL ROLL.**

In pursuance of the Notification No. SEC-01/2023/Pv/6 dtd 14/8/2024 issued by the Assam State Election Commission(SEC) and in conformity with Notification No. SEC-01/2023/Pv/60 dtd 14/10/2024, the draft Electoral Roll in respect of the Panchayat Raj Institutions of Dhubri Sadar Sub Division have been published today with date of eligibility of the voters as on 01.04.2024.

The Panchayat Electoral Rolls have been prepared as per Assam Panchayat (Constitution) Rules, 1995, by the Electoral Registration Officers notified by the SEC, by taking the relevant portion of the concerned Legislative Assembly electoral rolls published on 08/02/2024 w.r.t. 01/01/2024 as qualifying date.
