The vehicle shall be hired on the following terms and conditions:-

- 1. The Bidder must be properly fill up and submit the Profile of Bidder and Vehicles format. (Attach annexure A and B)
- 2. The type of vehicle should be one SUV(AC) category and other one should be Hatchback/Sedan(AC).
- 3. The maximum rate should be for SUV category Rs. 30,000.00 and for Hatchback/Sedan category Rs 20,000.00.
- 4. The Vehicle must be in perfect running conditions.
- 5. The vehicle must have valid insurance policy with all other relevant documents.
- 6. The provider will make the vehicles available at the office premises of DPMU, Dhubri daily on 10 AM to 6 PM. The hired vehicles are to be make available as and when required including odd hours and holidays.
