In pursuance of the W.T. Message received from the Commissioner, Food Civil Supplies Consumer Affairs and Legal Metrology, Assam Guwahati vide No.E-505108/207 dtd.09/10/2024 and in continuation of this office order No E-74227 FCS-31/39/2023-FCS-DBB/ 577 dtd-18/10/2024 the millers have submitted arrival report of Tide Over Wheat . Accordingly, allotment of 256.50 Qtls of W/Atta out of 270.00 Qtls of **Tide Over Wheat** quota for the month of **NOVEMBER/ 2024** is hereby made to the following FP Shop Dealers of Dhubri/Gauripur Town and SSM (part) bank by issue of scale @ **1.781 kg W/Atta** per PHH RCs.

The Secretary of DWCCS are hereby directed to lift the allotted quota on payment at Govt. fixed rate from the MC Mills, Dhubri are as follows:- (i) M/S Swapn Industries, Dhubri --- 85.50 Qtls. (ii) M/S Balajee Industries, Dbb--- 85.50 Qtls. (iii) M/S P.K Industries, DBB--- 85.50 Qtls.
The F.P Shop Agent/Dealers of Dhubri, Gauripur Town and SSM (part) bank will lift their allotted quota of the same as per allocation from the Secretary DWCCS at Govt. fixed price and will distribute amongst the PHH Ration Card holders tagged with each F.P Shop Agent/dealer as per scale of issue mentioned above.
The Secretary of DWCCS will submit arrival report to the concerned AO's directly for verification and will take necessary steps for onward distribution.
The Secretary of DWCCS will submit monthly return to the office of the undersigned in time.
The last date for lifting and distribution of Whole Meal Atta is **15/11/2024**.
