

MINUTES OF THE DDC MEETING HELD ON 05.12.2019 AT 11.00 AM IN THE CONFERENCE HALL,
DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Smti. Purobi Konwar, ACS, CEO, Zila arishad, Dhubri. She welcomed all the Officials present in the meeting and initiated discussion on the progress of schemes implemented by the different departments.

1. TOWN & COUNTRY PLANNING:

The Deputy Director, T& CP, Dhubri briefed the house on the implementation of different schemes under his department in the district. The Deputy Director informed that under PMAY-HFU, out of total targeted beneficiaries of 13924, a total of 1700 nos. of houses have reached the completed state. Another 650 nos. of houses are at roof level and 4204 nos. of houses are at lintel level. It was further reported that Geo-tagging of houses has been geared up with the improved app launched by the Central Government.

Further, in case of construction of Sapatgram Town Committee Building under 10% Pool Fund, it has been informed that the Civil Works of the Building has been completed. However, the Electrical works are remained to be done. The work is likely to be completed by March'2020 in whole aspects.

Regarding construction of Drainage system in Dhubri and Sapatgram M.B, it was reported that the schemes have been closed and the fund received earlier from the Govt. in this connection have been fully utilised and Utilisation Certificate submitted to the Govt.

2. FOREST :-

The DFO, Dhubri reported that the Task Force has seized Sal Timber =2.650 cum, Earth=32.942cum, Vehicle=11 Nos, Sand = 3.675cum, Stone = 7.654 cum, , Boat = 1 No, Bi-Cycle = 1 No. in the month of November'2019.

The Chairperson requested the DFO, Dhubri to submit clarify regarding the content of the letter wherein it has been directed to deduct and deposit 10% of the scheme for DMF in addition to 10% as Forest Royalty.

3. AH & VETERINARY:

The Dist. A.H &Veterinary Officer, Dhubri informed that the target for artificial insemination for the district has been fixed at 20,000 nos. and cumulative achievement of Calf Born till November'2019 is 4217nos. Under Prevention of Livestock Diseases, the target is 3,00,000 doses and they have provided 80864 doses till last month. In case of Deworming of new born Calf, it was reported that so far 9125 nos. of Calf were taken care under the scheme.

Regarding imparting training to the vaccinator, the Chairperson suggested to take the help of DPM, NRLM for persons to be trained as vaccinator and for this block-wise training camps may be held in consultation with the DPM.

4. APDCL:

It was informed by the AGM, Dhubri Electrical Division that they have received 196461 nos. of LED bulbs under MMADY scheme and has so far distributed 93556 (in packet of 4 nos.). Beside they have electrified a total of 517661 nos. of Households including additional 2711 HH.

The AGM, Dhubri Electrical Division further informed that at present the IPDS 2018-19 is under progress in the town of Dhubri, Gauripur, Bilasipara, Sapatgram and Chapar and the work is likely to be completed in the month of March'2020.

The AGM, Dhubri Electrical Division informed that he has taken up the mater regarding providing electricity connection to Moynabandha PWSS with his counter-part AGM, APDCL, Goalpara. As per information though they could not provided the connection to the PWSS because of pending payment of enhanced GST bill which is yet to be deposited by the PHE Department. The Chairperson requested E.E, PHE, Dhubri to take up the matter with the APDCL, Goalpara Division.

As resolved in the last DDC meeting the joint visit by the team of AGM, APDCL, Gauripur and N.H.Way Officials for on the spot study of shifting of Transformer installed near Beparipatty Masjid for installation of Signage in connection to Rupshi Airport couldn't be done. The Chairperson again directed for on the spot visit by the AGM, APDCL, Gauripur and N.H.Way Officials by today itself and sort out the problem.

It was further informed by the AGM, APDCL, Gauripur that the land for construction of 5 nos. of Control Units sanctioned for Dhubri District including two for Bilasipara Sub-Division has yet not been allotted. The Chairperson requested AGM, APDCL, Gauripur to take up with concerned Circle Officers for allotment of land.

5. PWD (NH):-

The AEE, Bilasipara NH-Way Sub-Division, informed that the construction of N.H.Way from Bangalipara to Tillapara has been completed. The AEE, Golokganj NH-Way Sub-Division informed that as resolved the repairing of N.H. Way on the stretch from Golokganj to Agomani has been done.

The AEE, Bilasipara NH-Way Sub-Division informed that as resolved in the last DDC meeting, he has submitted proposal for providing Reflectors on trees ahead of Chapar Town to the Higher authority for consideration.

6. Sales Tax Deptt :-

The Assistant Commissioner of State Tax, Dhubri informed that the revenue collected in the month of November, '2019 is Rs.63700910/- and the cumulative total stands at Rs.487478497/-.

It was further reported by the Assistant Commissioner of State Tax, Dhubri that the problem regarding collection of GST from the Brick Kilns has been sorted out and he has directed his Inspectors to visit Brick Kins to collect Taxes..

7. Irrigation Deptt:-

The EE, Dhubri Division Irrigation, Gauripur informed that renovation work of Asharikandi LIS Ph-I under SOPD-SCSP with an estimated amount of Rs. 52.20 lakh is under progress and so far 70% works have been completed. The Chairperson requested him to complete the work by December'2019.

Further, on query, the EE, Dhubri Division Irrigation, Gauripur informed that the selection of Beneficiaries under the scheme Pradhan Mantri Krishi Sichayee Yojana- Har Khet ko Pani (PMKSY-HKP) have been finalised and the Tender for Dhubri and Gauripur LAC has also been completed.

8. Health Dept :-

The Joint Director Health Services, Dhubri informed that altogether 5775 nos. of Full Anti Natal Check Up done in the District till October'2019. The Chairperson requested him to make suitable strategy for enhancing ANC Registration to meet up the requirement as fixed by NITI Aayog.

Regarding meeting up of shortage of ANMs in the Char Areas, the Joint Director Health Services, Dhubri informed that the Govt. has decided for Posting of local ANMs in these areas.

On query from the Chair, the Addl. C.M & HO, Dhubri informed that the first phase of Mission Indradhanush has been started from 3rd of this month and the same will continue throughout the week. He further informed that on the very first day they were able to achieved 26% immunisation and assured that the target fixed under the programme will be achieved.

Regarding the scheme distribution of Antara Contraceptives it has been reported that there is short supply of the same. However, they have achieved the target. In case supply of Antara is regularised, the achievement can be increased.

9. PHE:-

The E.E, PHE, Dhubri informed that the Geo-Tagging of 144788 nos. of IHHL out of 147477 (98.18%) for 2019-20 under Swachh Bharat Mission (G) has been achieved. He informed that the cent-percent Geo-Tagging cannot be done as because the IHHL constructed during 2013-14 couldn't be tagged.

The E.E, PHE, Dhubri informed that PWSS at Lakhimari Pt-III could not be made functional because of non availability of H.T Line. The Chairperson requested AGM, APDCL, Gauripur to take suitable steps for installation of H.T. Line at Lakhimari Pt-III village at the earliest.

It was further informed by the E.E, PHE, Dhubri that the existing Transformer at Tiamari PWSS installed by the APDCL has been removed for repairing but the same is not reinstalled till date for which supply of drinking water has been affected. The Chairperson requested AGM, APDCL for reinstallation of the same immediately.

10. Agriculture :-

The E.E, (Agri), Gauripur informed that a Soil Testing Centre will start functioning under RIDF in the Office Complex of DAO, Dhubri shortly. Moreover, work order for construction of 100 MT Godown for ADO, Alomganj has been allotted and the construction work will start soon.

Regarding, distribution of STW under RIDF, 2018-19, it was informed that the process for draft collection and distribution of STW to beneficiaries is going on and the target will be achieved by March'2020.

The DAO, Dhubri informed that the Tractors distribution under CMSGY 1st Phase has been completed and section of beneficiary groups for the 2nd phase is under process.

11. NABARD :-

The DDM, NABARD, Dhubri requested all Development Departments to propose Projects under RIDF Schemes of NABARD. He also requested departments to maintain quality of the works especially Roads projects and complete the works in scheduled time to avoid cost escalation.

It was further informed by the DDM, NABARD, Dhubri a workshop on development of Post Marketing Infrastructure for Agriculture Project will be held shortly for the betterment of farmers. He requested all concerned to participate.

The CEO, ZP, Dhubri requested DDM, NABARD, Dhubri to convene a meeting separately to discuss on all projects of NABARD.

12. DI&CC :

On query from the Chair, the G.M, DI&CC, Gauripur informed that the proposals under PMEGP has been forwarded to the banks and in this connection he requested LDM, Dhubri to extend necessary cooperation to achieve the target. The Chairperson requested G.M, DI&CC, Gauripur and LDM to take the matter with the banks concerned personally and achieve the target.

13. PWD (Building) :-

The E.E, PWD (Bldg), Dhubri informed that altogether 77 nos. of schemes are being implemented by his Division and so far they have completed 29 nos. of works. Beside, another 18 nos. of schemes are in progress whose achievement is above 80%.

On query he reported that the work of Medical College, Dhubri is in progress and so far about 46% works completed. He informed that as per extended time frame, the work is to be completed by 2021.

14. Sericulture :-

Regarding proposal for cultivation of Muga through Farmers Society, the Assistant Director, Sericulture, Dhubri informed that the land at Tushpara G.P. is suitable for Muga rearing. The CEO, ZP, Dhubri requested him to take up the matter regarding allotment of land with the Circle Officer, Chapar. She also directed him to submit Proposals for Muga cultivation through Gaon Sabha for consideration for implementation in convergence with MGNREGA.

15. Water Resources :-

The E.E, Dhubri W.R. Division, Dhubri informed that the work of the new scheme sanctioned under NABARD-RIDF for protection of one & half Km. of reach on the Right bank of down- stream of River Gangadhar has been started.

16. AUWS&SB :-

The Chairperson directed the E.E, AUWS&SB, Dhubri to sort out the matter of removal of electric wire line running over the Water Reservoir at Paulpara in consultation with AGM, APDCL in consultation with DDC, Dhubri.

17. Social Welfare :-

POSHAN Abhiyan :- The DSWO, Dhubri informed that they have received the necessary Weighing Machines and other instruments including mobiles under the scheme POSHAN Abhiyan.

MAHILA SHAKTI KENDRA :- As per direction of Govt. the recruitment of 1 no. Women Welfare Officer and 2 nos. of District Coordinator have already been completed and they have joined the duty.

PRADHAN MANTRI MATRU VANDHANA YOJANA (PMMVY) :- It was reported that so far they have uploaded 28334 nos. of beneficiaries under the scheme and so far 22708 nos. of beneficiaries have received fund.


18. BADP & Other Schemes:-

The House reviewed the progress of different schemes implemented under BADP, MPLAD, MLAADS and requested implementing agencies especially BDOs, & EE.PWD (R/R), Dhubri to expedite the completion of works and submit UCs.

MISCELLANEOUS :-

1. The DSWO, Dhubri requested Chairperson to take necessary action for handing over of AWCs constructed under MSDP, MGNREGA to Social Welfare Department.

The meeting then ended with vote of thanks from the Chair.


