MINUTE OF THE MEETING DISTRICT LEVEL NCORD COMMITTEE, DHUBRI DISTRICT HELD ON 24.04.2023 IN THE D.C'S CONFERENCE HALL, DHUBRI.

Members present-A

A District Level meeting of NCORD Committee, Dhubri was held on 24/04/2023. The meeting was presided over by Sri Dibakar Nath, IAS, Deputy Commissioner, Dhubri in pursuance of Govt. of Assam, Home & Political Deptt. Letter eCF No. 205449/223 dtd. 13.04.2023. While initiating the discussion, he welcomed all the members of District Level NCORD Committee present in the meeting and requested to participate in the discussion and put forward valuable suggestion if any.

The Chairman has read out the Govt. letter received from the Politial (A) Department, Dispur, Assam vide No. HMA-19030/1/2017-POL(A)/268(eCF-4219) dtd. 31st May,2022 and responsibilities fixed to the Committee for improving coordination among various stakeholders in the policy matters for improving the mechanism to tackle field –level issues as contained in the order of the Ministry of Home Affairs, IS-II Division, Govt. of India dtd. 25.03.2022 at Para No. 2 (IV) (b) of the District Level Committee.

He has requested the house to share whatever intelligence information about the trends of drug trafficking, illicit cultivation of Poppy or Cannabis crops etc. in the district and to present seenario on the matter in the District.

- 1. The Joint Director of Health Services, Dhubri was requested to constitute a joint team with Police department by engaging a Nodal Officer and to prepare a micro plan for implementation of NCORD.
- 2. The Inspector of School, DDC & DEEO, Dhubri opined to prepare a comprehensive plan of massive awareness among the students of Schools & Colleges so that the student can be awared the disease caused from chewing of "Gutkha" and other tobacco containing product. The house directed the Inspector of Schools, DDC, Dhubri to constitute "Nasamukti clubs" in every schools of the District and also to aware the parents of the students by issueing order not to use the "Gutkha" either in school or outside. He is also requested to submit the action taken report with photographs within 15 days on the matter as discussed.
- 3. The Drug Inspector, Dhubri is requested to submit the list of pharmacies who have installed CCTV camera in the pharmacies or not with photograph of the said pharmacies. He will also check the registration /licence of the pharmacies shop and visit the pharmacies with Police and Magistrate for checking the licence of the shops.
- 4. The Divisional Forest Officer, Dhubri is requested to visit in the forest land to find out cultivation of Poppy or Cannabis crops and to submit a detailed report with photographs.

- 5. The Dist. Agriculture Officer, Dhubri is requested to visit in the field to find out whether Poppy or Cannabis crops are cultivated by engaging his field level Officer /VLEW and submit report with photograps if any.
- 6. The Superintendent of Excise, Dhubri is requested to activate his sources to inspect the char area of the District wherein the poppy or cannabis crops may cultivated as well as to launch massive drive for checking illicit liquor and submit action taken report thereof
- 7. The AC(OPS) SHQ, BSF, Dhubri has informed the house that there is no poppy crop in the villages of Indo-Bangladesh bordering area of the District.
- 8. The Inspector, Customs Division, Dhubri was asked for lunching a drive for checking of transportation of Ganja, Poppy by the drugs paddlers in the district. In this regard it is directed to check the suspected vehicles properly and share the information if any

All the respective stakeholders were instructed for submission of action taken report within 15 days to the Chairman. However, as per Govt. instruction a monthly review meeting will be held regularly and attendance of representatives present in the meeting alongwith minues of the meeting will be uploaded in the portal along with the minutes of the meeting.

The meeting ended with a vote of thanks from the Chair.
