MINUTES OF THE DDC MEETING HELD ON 27.02.2023 AT 11.00 AM IN THE CONFERENCE HALL, DEPUTY COMMISSIONER'S OFFICE, DHUBRI

Member present: As per Annexure:- 'A'

The meeting was presided over by Sri Dibakar Nath, IAS, Deputy Commissioner, Dhubri. At the outset, he welcomed all the members present in the meeting.

Thereafter, the Deputy Commissioner reviewed the departments as follows:

1. AH & VETERINARY:

Referring to discussion held in the DDC meeting during January/2023, DVO stated that all the domestic animals have been already covered under Foot & Mouth Disease (FMD) control programme of targeted figure of 57,935 nos.. In a reply from the chair, DVO informed that under fodder cultivation scheme, a large nos. of applications has been received from the farmers and same has been approved to provide the benefit. The Chair asked the officer to ensure visit of all the field level workers at their respective allotted sites to identify diseased animals with proactive steps with adequate medicines.

2. <u>FISHERY</u>:

Progress of all the schemes under fishery department were reviewed by the meeting. DFDO informed that under RKVY-RAFTER scheme two nos. of waterlogged areas have been converted into fishery pond owned by the SHG funded from Directorate of fisheries at the rate of 6.50 lakhs. The Chair reviewed progress of different component under PMMSY and asked the officer to ensure completion before the next monsoon. DFDO informed that a cumulative production of 9866.19 MT fish could be achieved out of total target of 12506 MT for the year 2022-23 covering different water resources.

3. SOCIAL WELFARE:

DSWO informed that SNP is smoothly going in the district with achievement of physical target of 99,357 MT nos. against 6 services. He stated that 8 nos. of Model AWC against 10 nos. of targets have been completed and construction of other 2 nos. are nearing completion. In a query from the chair, DSWO informed that with a view to provide rehabilitation to drugs addicted persons Nasha Mukt Bharat Abhiyan is smoothly going on in collaboration with some NGOs working in the field. The Chair asked the officer to submit a report about holding of disability camp and the nos. of Pwd found out.

4. <u>EDUCATION</u>:

The Chair reviewed progress of different civil work constructions carried out under SSA & RIDF and asked the officer to ensure completion before the next monsoon. As sought for by DMC, SSA, AGM, APDCL informed that electrification of the schools has been completed except a few which would be resolved immediately.



5. **WATER RESOURCES:**

The meeting reviewed progress of all the 5 nos. of ongoing schemes under Water Resource Division and asked the E.E to ensure completion within stipulated time period. The Chair asked the E.E to inform the reason about poor progress of the road cum bandh at Fakirganj area taken up under SDRF 2021-22. The officer stated that the work is still going on and it is expected to complete by March/2023. The Chair asked the officer to complete all SDRF, SOPD and NABARD funded works before the next flood.

6. P.W.D. (BUILDING):

The meeting reviewed all the major and important constructions carried out by PWD(B) department. The Chair asked the E.E to ensure completion of all the components of works at Madhupur Satra under ACA 2016-17 latest by 31st March. He also asked the officer to arrange a meeting with all the contractors to review the progress of construction against which physical achievement are not up to the mark.

7. Health:

The meeting reviewed progress of different schemes under Health sector. In a query from the Chair, the Joint Director of Health Services informed that due to shortfall of Anesthetists, different types of operations including delivery could not take place particularly in Chapar CHC leading to increase in child mortality rate. The Chair asked the officer to communicate the higher authority to engage adequate Anesthetists with a copy to this office. The shortage of manpower in different categories of Health department was also discussed in the meeting. The Chair asked the officer to communicate the higher authority accordingly. The Chair informed that a large numbers of Health infrastructure had been constructed under MSDP /PMJVK scheme. He asked the officer whether the buildings have been occupied and to furnish a report on individual construction. He was also asked to obtain the list of Health institutions from the T&D Branch, Dhubri.

8. PHE:

The Chair reviewed status of FHTC scheme in Dhubri district and expressed dissatisfaction on poor percentage of achievement. He asked the officer to take appropriate steps to achieve the target within time. The meeting also reviewed progress of new PWSS and Retrofitting PWSS with status of handing over of the same to PRI or Users' committee. He informed that a total number of 1040 nos. of school and 1558 nos. AWCs have been provided with running water facilities. The Deputy Commissioner asked the officer to complete all the projects of SBM(Grameen) within the targeted time and to arrange a separate meeting for the same immediately.

9. DICC:

After review of progress of different schemes implemented by DICC, the Chair expressed his displeasure on poor performance particularly on PMEGP scheme. It has been observed that out of 594 nos. of sponsored cases, a total of 124 nos. of cases got sanctioned from different banks. The report also does not reflect financial status against sanctioned cases under all the categories of DIC, KVIC & KVIB. The Chair asked the officer to submit physical & financial progress under PMEGP. Henceforth, he was also asked to submit the list of banks wherein sponsored cases have been lying pending and to pursue the banks to resolve the



The Chairman asked all the officers to ensure regular submission of progress report on major & important schemes which should reach this office on or before 2nd day of the succeeding month. He also requested to intimate interdepartmental issues to place before the meeting to resolve in consultation.

The meeting ended with vote of thanks from the Chair.
